\$100,000,000 NAVY BASE VOTED DOWN

Senate Refuses Appropriation for Project at Alameda, California

VOTE 40-30; NO PARTY LINES

Washington, May 24.—Advocates of economy in Federal expenditures won their first big victory yesterday when the \$100,000,000 naval base project for Alameda, Calif., on San Francisco Bay, was voted out of the Naval Appropriation Bill by a decisive majority.

Middle Western Republicans, voting with the Democrats, disregarded the pleas of the party managers in the Senate and gave the Naval Affairs Committee a severe trouncing. The vote was 40 to 30 against adoption of a committee amendment which provided for establishment of what was intended to become one of the world's greatest naval bases.

An appropriation of \$1,500,000 recommended for "development" was denied, as it was not the opening wedge to be followed by substantial appropriations in the future.

The Alameda project was urged with special emphasis by Senator Lodge, majority floor leader, but he could not hold the Republicans in line in the face of the withering fire directed against the "real estate deal" by Senators Borah, King and La Follette.
