PRICE MOVEMENT VERY CONFLICTING

Receivership Proceedings for Interborough Were a Disturbing Element

New York, Aug. 29.—Cross currents made price movement of today's stock market not only irregular, but at times conflicting and confusing.

As would be expected under the circumstances, the market had a weak and strong spots. In some quarters the overzealous short interest again had a very unbecoming time of it in squeezing out of a box.
