KIDNAPPING CHARGE IN ALIENATION SUIT

New Sensation Features Troubles of Joseph Paterno and Charles Prince. ACCUSED WIFE AT HEARING.

New York, Jan. 16.—Another amazing situation has been woven into the skein of difficulties involving the families of Charles Prince, wealthy dealer in Oriental art works, and Joseph Paterno, millionaire real estate owner.

For two hours at Lakewood, N. J., on Saturday, Mr. Prince tried to convince Town Justice J. J. Scher, sitting there he was kidnapped by Paterno and others and held incommunicado for several hours.

They, on the other hand, entered the defense that there was no coercion. The court dismissed the complaint, but not until after Prince had managed to place on the records some of the allegations on which he had previously based a suit for \$100,000 against Paterno, charging alienation of the affections of Mrs. Alice Prince.

Her position to embarrassing to permit her to sit either with her husband or Paterno, the beautiful Mrs. Prince was an isolated figure in the courtroom. She was ready to testify to a certain phase of the "kidnapping" incident, but was not called.

They made unique by reason of the facts that on the one hand she is accused by her husband of having yielded to the blandishments of Paterno and, on the other, she has been denounced by her sister, Mrs. Julia Paterno, wife of Joseph Paterno.

Taken to Jail in Bathing Suit. Prince testified that the alleged kidnapping was on July 16 last, when he was bathing with Holland at Point Pleasant. He had previously consulted with Holland a number of times on suggested "cases against Paterno."

Soon after he reached the house he was arrested, taken to the Toms River courthouse, and in bathing suit and robe, and kept in a room there from 1 P. M. to 7 P. M., and being given no opportunity to communicate with counsel. His wife, in a bathing suit and robe, and signed a paper. The nature of this document was not brought out in court, but it is known it had to do with the alienation charges against Paterno.
