TAKE UP ORDINANCE FOR BUILDING TRACT

Wister Estate Offers City Ground Worth \$267,000 for Roads in New Section

PLAN HUNDREDS OF HOUSES

To enable builders to erect several hundred homes in the northern section of the city, an ordinance was taken up by Council's Committee on Public Works today, authorizing revision of laws which govern the section bounded by Sixteenth street, Church lane, Twentieth street, Ogontz avenue and Olive avenue.

William R. Nicholson, president of the Land Title and Trust Company, said that builders desired the ground to erect dwellings much needed in the neighborhood and report back to the committee.

The bill was referred to a subcommittee, which will inspect the neighborhood and report back to the committee.

A long forgotten project to cut Forty-fourth street through the Pennsylvania Hospital for the Insane, known as "Ricker's," was a long controversy, the Supreme Court decided the city had a right to cut through the institution, but the plan was abandoned.

Today the committee considered an ordinance to repeal the ordinance giving the city the privilege.

Owen J. Roberts, counsel for the institution, said "it would cost a poor charity a lot of money if a street were cut through."

Councilman Frankenberg took exception to this. He said it was not a poor charitable institution, and he understood it had some wealthy patients. Mr. Roberts said the institution made no profit.

Councilman Frankenberg said he understood a plan was being considered to tunnel under the ground of the institution, and moved the repealer be reported with an unfavorable recommendation. The committee approved.

A resolution proposing that the Parkway from the Hall to Fairmount Park be called Marshall Park, Church lane, given a sleeping porch by the company. It had been introduced by Richard Wiegman, council president, at the request of the Stenton Girard Post of the American Legion.

Mr. Wiegman said it was his duty to introduce the resolution, but he did so with regret. He said it was "repugnant" that the post should put out a sign here for the proposed honor and said the name "Parkway" would be more suitable.
