

### M'CORMICK SOON TO SAIL FOR EUROPE

Patient in Gland Operation Expected to Leave Hospital This Week

### YOUNG MAN FADES AWAY

Chicago, June 20.—Harold F. McCormick, millionaire chairman of the Executive Committee of the International Harvester Company, may be able to leave Wesley Memorial Hospital by Wednesday or Thursday of this week. After a brief rest at home, it is thought he will go to Europe for an extended visit.

Mr. McCormick's friends were assured yesterday that the gland transplantation had been entirely successful. It is said the patient discovered, for the first time, that having undergone the operation had become a public man, and became so angry that he ordered the dismissal of several hospital employees. He sent out for the newspapers, and after reading some of the accounts gave twenty-five orders that they were not to be discussed by any one in the hospital. Guards were stationed around the section of the hospital which has been walled off for him, his surgeon, his nurses and nurses, with instructions to turn away all but members of his family.

It is said that the youth through whom the operation was made possible has disappeared. Having served his purpose, the young man has been secretly removed from the Wesley Memorial Hospital. He appears with the usual air of the McCormick fortune, leaving behind him the kind which is expected to bring him the size of youth to his harvests.

Since the operation became public knowledge, it was alleged yesterday that the president of the accompanying financial institution, the Chicago Trust Co., is a close friend of Mr. McCormick. It is reported that Mr. McCormick is a millionaire and one of the foremost men of Chicago, while the former gland patient was a young man of social position, and that it would be embarrassing to have the young man "fade away."

Among those who attempted to call upon Mr. McCormick was a young man, a hatter and milliner, who had his name as Bridges. He had reported he was from the Edward H. Ross Hospital, and was the cousin of Max (Ward) who, it is reported, was a member of McCormick's family.

Dr. Victor D. Lespinasse, noted gland surgeon, who performed the operation, today issued the following statement: "Harold F. McCormick is in excellent spirits, and his condition, surgically, is all that could be desired. Last night, at his office, Dr. Lespinasse said that Mr. McCormick was improving, and that he would allow him to go home in a few days. It was reported that Dr. Lespinasse had been refused a fee of \$25,000 for the operation, and that he was doing without publicity. It also was said that the hospital received a promise of an endorsement of the article in their sewer. All who had knowledge were warned that rumors discussed would be the penalty for talking of it."

### Secret Kept Five Days

For five days the millionaire succeeded in keeping a secret from public knowledge. It is reported that he was well and Dr. Lespinasse was expected to return to his office on Saturday. It was learned that Mr. McCormick had been refused a fee of \$25,000 for the operation, and that he was doing without publicity. It also was said that the hospital received a promise of an endorsement of the article in their sewer. All who had knowledge were warned that rumors discussed would be the penalty for talking of it.

An invitation was issued yesterday to Dr. Lespinasse to give a lecture on the gland operation at the University of Pennsylvania Hospital on June 21. It will discuss the operation.

### SAY HE KILLED WIFE AND MOTHER-IN-LAW

Georgian's Motive for Crime Believed to Have Been Jealousy

Statesboro, Ga., June 20.—It is believed that the motive for the shooting of his wife and mother-in-law by a Georgian was jealousy. The man, who is named as Patrick, was held at the Statesboro County Jail in Virginia today, where he was awaiting transportation to a safe-keeping following the arrest after discovery of the crime.

Patrick, who had been separated from his wife for several years, was said by the authorities to have confessed to shooting the two women in an impulse of jealousy over his alleged attentions to other women.

### CHAINED OMAHA WOMEN TO KEEP THEFTS SECRET

Man Shot and Captured in Wyoming Explains His Motive

Rawlins, Wyo., June 20.—A. P. Forster, the man who could not get the police that he had in his possession stolen jewelry, had him to find two Omaha women in chains in a nearby house. Fred Brown, who was captured by Wyoming officers after a chase from Nebraska, declared in a statement from newspaper men here today.

Brown, who is at the State Prison Hospital, is recovering from a bullet wound inflicted during the chase. He will be returned to Omaha to answer several charges.

"This all began in Omaha soon after I had visited a resort known as the 'Wichita,' where I met a woman who accompanied me to my house, where she visited me many times in the next four months," Brown said. "Once she brought a lady friend to my house, where both proceeded to make themselves at home. Upon returning to the house I saw that they had been snooping around and found a kettle of jewelry that I had hidden. I heard them say that I was a thief with all that jewelry, and threaten to tell the police. There was only one thing for me to do—chain them up until I could dispose of the jewelry to a fence and make a get-

### 'MYSTERY WOMAN' IS WARD'S SISTER

Relative Testifies at Hearing She Knew Nothing of Blackmail

New York, June 20.—Mrs. Isabel Stanford Wood, sister of Walter S. Ward, testified yesterday at the hearing to determine whether members of the Ward family conspired to defraud justice in connection with the slaying of Clarence Peters. She and her husband had been subpoenaed to appear before Justice Macintosh, sitting as a magistrate in White Plains.

Mrs. Wood turned out to be the "mystery woman" witness whom the authorities were seeking on Saturday. She had been with her husband at the Garden Farm, Hoped, District Attorney Weeks hoped to gain from her the story of the alleged blackmail plot which, Ward's lawyers contended, was responsible for the shooting of Peters in the pistol "charade."

Mrs. Wood said that she had no knowledge of any blackmail plot against any of her relatives, no knowledge of the shooting of Peters, until she read of it in the newspapers, and knew nothing further about it than that she had read about it. She had not discussed it with her father or brother, and they had not told her anything about either blackmail or the shooting, she said. Mr. Wood, who followed her as a witness, said he never had heard of any blackmail, and had not talked about the shooting with any of the Wards.

Ralph Ward then was recalled and questioned about his father's trip to the Middle West. Mr. Ward, Sr., was

reported in Cleveland last night. He said he made reservations months ago for his father to go on a business trip for inspection of baking plants, and that he was certain his father had not gone away to avoid court subpoena, but merely was compelled by business to leave.

He also said he talked with his father on the long distance telephone, including interesting details for rejuvenation of the aged and thyroid glands for mentally backward children.

District Attorney Weeks had hoped, through the hearing, to prove that a conspiracy existed, and thereby obtain a warrant on which George Ward could be arrested and extradited. The Grand Jury which indicted Walter Ward meets again tomorrow, and Mr. Weeks had planned to present conspiracy evidence before that body.
