

STOCKS IN SUPPLY AT CONCESSIONS

Declines Follow Uncertain Opening and Early Demonstration of Strength

New York, Sept. 30.—Unsettled conditions prevailed in security trading markets this morning and in the short interval of business there were violent declines following an uncertain opening and a short demonstration of strength in the early forenoon.

The action of the market was regarded as evidence that the highest prices reached on the upturn late yesterday were due largely to covering of shorts, and that with the absence of buying of this character there was no sustaining influence when liquidation and forced sales of weakened accounts were resumed at the end of the week.

Speculative "short" traders launched a series of attacks against stock prices this week, which resulted in declines of 2 to 5 points in a number of active issues, while others generally advanced to the extent of 1 to 2 points in the nature of a correction of a weakened technical condition.

The action in some issues was even more pronounced than those in the stock market, foreign issues being particularly weak in the afternoon.

Except for the four showing noted in the railroad in August, which the market had largely secured during the course of the previous month, developments were in the main favorable.

Steel tonnage is now at 70 per cent of capacity and the anthracite situation is more favorable than it was in September. It is expected to show the largest increase in output this year.

Money rates continue to be relatively easy. The reaction in the stock market has resulted in a substantial distribution in the commercial paper market.
