Brilliant Affair at Belmont.

A REBEL CAMP CAPTURED AND DESTROYED

Both our Generals had their horses shot from under them. Col. Dougherty of Illinois, was wounded and taken prisoner by the Rebels.

The Rebel loss is not known. The Government loss is believed to be from three to five hundred.

Further Particulars of the Battle at Belmont. Chicago, Nov. 8.—A special dispatch to day gives the particulars of the fight at Belmont, yesterday.

Our force consisted of the following Illinois regiments: Twenty-second, Col. Buford; Thirtieth, Col. Foulke; Thirty-fifth, Col. Logan; Seventh Iowa Regiment, Col. Lamson; Taylor's Chicago Artillery, and Dolen's and Delano's Cavalry.

After taking possession of the Rebel camp it was discovered that the Rebels were crossing over from Kentucky for the purpose of attacking us in the rear.

Another severe engagement took place in which our troops suffered seriously. We have two hundred and fifty prisoners, a number of whom are wounded.

The gun-boats rendered efficient service in covering our retreat, mowing down the rebels with grape. Some of our men were killed by the fire.

THREE FORTS CAPTURED.

RUMORED CAPTURE OF CHARLES-TON.

NEW ORLEANS IN JEOPARDY.

BALTIMORE, Nov. 13.—Passengers by the Old Point boat report that the fleet of five which arrived yesterday from Norfolk had a number of reports, one was that after the capture of the three forts at Port Royal by the U. S. troops, the Rebels fell back to Beaufort, where a terrible struggle took place.

Four fishermen, who came in from across James River last night, corroborate the report of the capture of Charleston which had been received through five deserters on the previous day.

The Norfolk Custom House, together with a large amount of stores, was entirely captured by fire on Sunday night last.

CAIRO, Ill., Nov. 11.—The Memphis papers received here to-day contain a dispatch from Savannah fully confirming the landing of the Naval Expedition at Beaufort and the capture of the three Rebel forts at Port Royal, Hilton Head and Beaufort.

The Federal forces had possession of the town of Beaufort. The Rebels acknowledge their loss to have been very large. Our loss was eight men and one officer.

We captured everything, including many of the officers' swords and commissions, all the public and private papers and letters, among which was a telegram from Jeff. Davis to the commander of the port, informing him of the sailing of the fleet, and that its destination was Port Royal.

The Southern papers also speak of an immense fleet in the mouth of the Mississippi and that an attack on New Orleans is hourly expected.

THE UNION SETTLEMENT BECOMING TROUBLESOME.

Railroad Bridges Burned to Retard the Progress of the Rebels.

PHILADELPHIA, Nov. 12.—The Union men of East Tennessee have burned numbers of Railroad bridges and telegraph wires to prevent the transportation of troops.

Four stragglers on the line north of Knoxville were on Saturday destroyed. A very heavy wooden bridge at Charleston, Bradley county, Tennessee, was destroyed on the evening of Friday last.

It is said that great numbers of the secessionists of Kentucky who joined the confederates are now leaving their camps and returning to their homes thoroughly disgusted and much wiser men.
