Reputation and the 'Rebel Brigadiers.'

From Richmond (Va.) Commonwealth, February 12.

Where was the Republican vote of the State of Virginia cast in the late election? It was cast for the gang of Repudiators that this day defile the legislative halls of the State of Virginia. The negroes, who constitute the Republican party of the State, cast their votes solidly for Repudiators for the Legislature.

Where was the vote of the "rebel brigadier" cast in that election? It was cast solidly, with one exception, for making our State pay the debt that she owes.

The ranks of Confederate officers above the grade of Brigadier-General who reside in the State of Virginia may be scanned, and it will be found that there is but one who tolerates the idea of repudiation, and that one is Major-General William Mahone. First—General: General Joseph E. Johnston.

Second—Lieutenant General: General Jubal A. Early.

Third—Major-Generals: Generals Fitz Lee, W. H. F. Lee, D. H. Maury, Robert Ransom, H. Heth, J. L. Kemper, Jas. A. Walker, L. L. Lomax, Wm. Smith, G. C. Wharton.

Fourth—Brigadier-Generals: Generals William H. Payne, Lindsay Walker, McComb, R. D. Lilly, D. A. Weisiger, John Echols, R. L. T. Beale, Joseph R. Anderson, John R. Cook, Eppa Hunton, J. H. Lane, M. D. Corse, Beverly Robinson, T. T. Mumford, Wm. R. Terry, T. M. Logan, Williams C. Wickham.

There may be other general officers living in the State of Virginia, but they are not now recalled. Every man of the gallant array, who devoted their lives and their fortunes to the Confederate cause, demands that the State of Virginia shall pay her debt, and they look upon every confederate soldier who votes and co-operates with the Repudiators as a deserter.

These "rebel brigadiers," who have been derided and slandered as disorderly, lawless desperadoes, are the law-and-order element of our society, and the voters who constitute the Republican party of Virginia are what has made the State of Virginia a repudiating State, against the fierce and angry protest of the "rebel element."

If the horrible bill for repudiating our State debt, which has just been presented in our Legislature by Mr. Riddleberger, be passed, it will be by Republican votes, against the protest of the "rebel element."

We want the world to know this fact, and we intend that it shall know it. We intend to make it known that the "rebel element" demands, as an act of justice to itself, that it shall have an opportunity to pay back money we have borrowed, but that the Republican party will not let them, and that the Republican party is to-day placing the State of Virginia before the world as a repudiating State.

Federal Election Laws.

WHAT THE DEMOCRATS IN CONGRESS PROPOSE TO DO ABOUT THEM.

Special Dispatch to the Record.

WASHINGTON, February 11.—The Democrats having failed to repeal the Federal election laws, they will do the next best thing from their standpoint—amend them. Senator Wallace's bill, introduced a day or two ago, making it unlawful for any marshal, deputy marshal or supervisor to arrest any election officer on the day of election, but providing that a warrant may be executed on any subsequent day, is intended to remedy one of the evils complained of in the Federal election laws. The Republicans in Congress have invariably expressed a willingness to correct any defects in the laws, and proper amendments will not be opposed by them. The power of summary arrests now vested in marshals, their deputies and supervisors so directed, to deprive a polling place of all its election officers. The President, in one of his veto messages sent to the extra session, advised that the election laws be amended and strengthened rather than repealed, and hence it is assumed that he will not object to proper amendment.
