MODEL CONSTITUTION OF THE JEFFER SONIAN DEMOCRATIC ASSOCIATION OF YORK, PENN'A.

The following is the constitution and by laws of the Jefferson Democratic Association, of York, Pa., just formed in that place, under the Presidency of

Mr. C. S. Black:

NAME.

This association shall be known as the Jefferson Democratic Association, of York, Pa.

Its purpose shall be the association of Jeffersonian Democrats for the preservation of the Constitution of the United States, the autonomy of the States, home rule, freedom of elections; for resistance to revolutionary changes tending to consolidation of empire; to the election of any person to the Presidency a third time; to the presence of regular troops at the polls; to any appropriation of public money to any purpose but the support of Government; to commercial restrictions for the benefit of the few at the cost of the many; and to class legislation which despoils labor to build up monopoly. To these ends we invoke the spirit and reas-sert the principles of Thomas Jefferson, the author of the Declaration of Independence and the founder of the Democratic

OFFICERS.

The officers of the association shall be a president, vice-president, secretary, treasurer, corresponding secretary and financial secretary.

sary to adopt the same MEMBERSHIP.
SECTION 1. Propositions for the election of active members shall be made in writing, and the names of the candidates for membership shall be accompanied by the names of the members proposing them. Their names shall be referred as provided in section 2, article V. of the constitution, nd they may be voted for at the meeting t which the "Committee on Applications or Membership" make their report, and

for Membership "make their report, and on receiving a majority of the votes cast, and paying a fee of membership of \$1, they shall be members of the association.

SEC. 2. A member opposing the election of a candidate for membership shall not be heard in open meeting of the association, unless he shall have first stated his objections before the Committee on Applications for membership. ations for membership.

SEC. 3. Honorary members may be proposed and elected at the same meeting, provided that one honorary member only shall be elected at one and the same meeting, and two-thirds of the votes cast shall be necessary to an election. They shall be exempt from the payment of fees of membership and dues and shall have all the privileges of active members except to vote and hold office.

SEC. 4. Members of other Jefferson Associations shall have the privilege of attending the meetings of this association and participating in its discussions.

ANNUAL MEETING.

There shall be an annual meeting of the association held on the birthday of Thomas Jefferson, and when that day occurs on Sunday such meeting shall be held on the day thereafter, at which all elections of officers shall be held, and the terms of the officers shall be held, and the terms of the

officers shall begin and end.

PARLIAMENTARY LAW.

The rules of parliamentary practice

comprised in "Jefferson's Manual" shall govern the association in all cases to which they are applicable and in which they are not inconsistent with the constitution and by laws.

QUORUM.

Nine members shall constitute a quorum.

SUSPENSION OF BY-LAWS.

By-laws may be suspended by a vote of
