

The Pope.

NO LONGER SECURE IN THE VATICAN—EXILE IN PROSPECT.

ROME, October 17.—The pope, in his address to the Italian pilgrims at St. Peter's yesterday, stated that the deplorable state of affairs placed before him the alternative of enduring continual captivity, made harder daily or of going into exile. He therefore asked Catholics to watch and pray for the liberty and independence of the pope. He concluded by saying that he was no longer secure in his palace; that he was outraged in his person and dignity in a thousand ways.

The gravity and earnestness of the pope made a profound impression. He closed his address with his arms raised to Heaven as though imploring help.

THE ITALIAN PILGRIMS ASSAULTED.

LONDON, Oct. 17.—A dispatch from Rome to the Times says: "It is impossible to describe the enthusiastic cheers after the pope gave his benediction on the occasion of receiving the Italian pilgrims at St. Peter's on Sunday. The pope looked thin, worn and anxious. A gang of roughs pelted the pilgrims when they were leaving the church of St. Vitale, shouting, 'Down with the Vatican!'"

The Mrs. Garfield Fund.

WASHINGTON, October 9.—Saturday the United States trust company of New York had registered at the treasury department \$275,000 in four per cent. bonds in the name of the company as "trustees for Mrs. Lucretia R. Garfield and the surviving children of James A. Garfield, deceased," being the amount purchased with the proceeds of subscriptions to the Garfield fund. These bonds will yield an annual income of \$11,000, and cannot be paid off by the government until the year 1907.

It has just leaked out that while Gen. Grant was traveling in Asia he expressed a desire to get a shot at a lion. Not wishing to expose him to danger the natives secured a stuffed lion, set it up in a jungle, and then took the illustrious traveler out for a hunt. When the beast was sighted the General was all excitement, and crawling up to a favorable position began to blaze away at the animal with no perceptible effect. After firing about twenty shots he began to get mad, and taking off his coat, he settled down for a regular siege. Fearing his wrath when he discovered the sell, the attendants endeavored to induce him to give up the attempt to kill the beast, telling him that it had bore a charmed life and that he could not possibly injure it. He told them to go to thunder; that he was after blood, and was going to have it. After a vain fusillade of half an hour, he arose to his feet gnashing his teeth with rage, three his suspender off his shoulders, rolled up his sleeves, and grabbed his rifle by the barrel, so he could use it as a club. The attendants again begged him to desist; but he politely, though forcibly informed them that he would have that cuss or leave his honored remains strewn promiscuously all through the jungle, and with a wild cry of, "I'll fight it out on this lion if it takes all summer," he rushed upon the beast, and with a well-directed blow had it over on its side. Then he chased the native attendants for six miles, but, being better acquainted with the country, they got away from him in safety.

According to an estimate made by the Indianapolis Sentinel, the illness and burial of the late President involved an expenditure of about \$347,000. Of that sum \$247,000 were spent at Cleveland and \$100,000 during the patient's struggle for life. Mr. Garfield's private secretary, Mr. Brown, kept the run of things until the fatal termination. He says that the doctors' bills probably will prove to be \$53,000 and that the average daily expense approximated \$1,250. The sickbed expenses, as Mr. Brown thinks, will be borne by Congress and there seems to be a settled conclusion that the \$247,000 incurred at Cleveland are to come out of the Ohio State Treasury and the Cleveland people. The decorations in Cleveland cost \$103,000; the accommodations, \$100,000; the arches, \$5,000; the catalogue, \$3,000; the music, \$2,000, and so on. The transportation of the remains from Elberon to Ohio was the work of the Pennsylvania Company, which, it is understood, will make no charge. Accompanying the estimate of the sick bed and funeral expenses is a statement that Mrs. Garfield is likely to receive a pension of at least \$3,000 a year, which will make her income about \$15,000.
