McHaleremonstrated with Kehoe, when angry words fol lowed and finally the two clinched and McHale was worsted. 



#### The Express Robbery.

Rath Pratt, the imprisoned clerk of the Adam-s Express Company, who is charged with being the perpetrator of the robbery of over \_\$32,000 in money from the Company about ten days ago, still protests his innocense of the crime. Before being taken to prison he was subjected to a rigid examination at Detective Spittall's office, with the view of wringing a confession from him. Pratt was equal to the emergency, and could not be made depart from his original declaration of innocence. "I will employ the best counsel I can procure," he said, "and I will sue the Adams Express Company for false imprisonment, and defamation of character. If that should be my luck I will kill myself and that will be the end of it."
