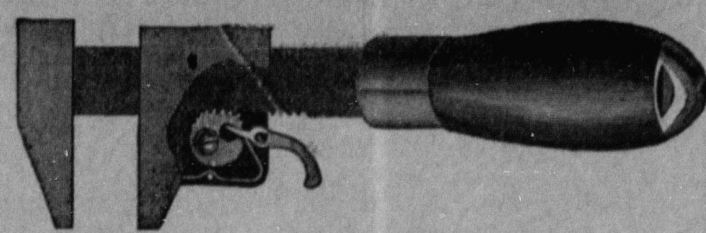

**Tumor Removed.**

Dr. F. P. Baer, of Philadelphia, yesterday performed a skillful operation on Miss Clara Devling, of this city, and removed successfully an ovarian tumor weighing 75 pounds. Miss Devling, the patient, is only 21 years of age and the tumor had been growing but four months. Considering the lady's age and the size of the tumor, the Doctor says he never seen anything like it, although he recently removed a tumor weighing ninety pounds. Dr. Baer was assisted by Doctors Armstrong, Ball and Watson. Miss Devling is doing finely and there is every reason to hope for a speedy recovery. The tumor was removed by making an incision through the abdominal walls.—Lock Haven Express.

**A Boiler Blows Up.**

ELLENDALE, Dak., Sept. 6.—The boiler of Goulette & Letson's threshing outfit exploded near the Manitoba depot about eight o'clock last evening. A crew of ten or twelve men were engaged near by, and of this number eight were either killed outright or badly injured. C. J. Goulette, one of the owners, was steering, and was blown six rods. He was badly scalded and bruised, but not fatally hurt. An old man named McLean was instantly killed, four young men named McKinsie, Johnson, Memory and Griffin, sons of prominent citizens, are terribly wounded and will hardly recover. The other two who were injured will undoubtedly recover. The explosion scattered fire in all directions, and in a few minutes the prairie grass was blazing around the victims of the disaster, some of whom would have perished but for arrival of assistance. The exact cause of the accident is not known.

**A Yellow Fever Horror.**

ST. AUGUSTINE, Fla., Sept. 6.—A letter has been received in this city disclosing a terrible state of affairs in the town of Bayard, a small settlement on the line of the Jacksonville and St. Augustine railroad about twenty miles north of here. William Origus, the son of a farmer living at Sampson, five miles north from Bayard, had occasion to visit the latter place. On nearing the settlement he was attracted by a strong stench emanating from the vicinity of a house supposed to be vacant. Through curiosity he proceeded to investigate. On reaching the house a ghastly spectacle met his eyes. Stretched upon a couch was the body of a woman, and in the same room were the bodies of five children. They had evidently been dead several days. The boy on realizing the horror of the scene fled, and mounting his horse rode back to his home and told the startling story. As St. Augustine is strictly quarantined against Bayard and that vicinity the news did not reach here till several days after the occurrence. The country people are horror-stricken, and even if it were known that any one was occupying the house, it is unlikely that any one of them could have been induced to go near it if he knew there was a case of yellow fever. It is supposed that the unfortunate were refugees from Jacksonville, and were stricken with the disease after leaving town.

**Killed by Falling Logs.**

SELENGROVE, Pa., Sept. 6.—R. Bruce Swengle, the young man who several weeks ago taught a class of young men in the art of penmanship and drawing, was instantly killed yesterday at Pardee, Union county Pa. He was engaged in teaching there, but finding the need of outdoor exercise he secured a situation on the Pardee lumber works and was in the act of coming down the mountain on a train of logs when a truck under the car of the one on which he was riding, jumped the track, causing several large sticks to be thrown off, one of them striking him on the breast and killing him. His body was taken to his home in Paxtonville, and will be buried on Saturday. He was 24 years of age, and a son of C. P. Swengle, a lumberman.

**A Dead Man's Body in a Creek.**

BETHLEHEM, Pa., Sept. 6.—M. W. Rice, track walker on the North Penn railroad at Hellertown, yesterday morn-

ing found the body of a man lying in the Saucon creek, near Benner's mill, in that town. An examination of the body showed a wound over the hip and a fracture of the right leg. The body is supposed to be that of Charlie Owens, a stranger who came to Hellertown several months ago, and was employed at the iron works. He has been missing for three days. How the man met his death is a mystery. Coroner Weaver is making an investigation.

**Ada Flynn Murdered.**

It seems that Mr. Troxell and his wife left home on Thursday morning to attend an Odd Fellows' picnic at Allensville, leaving Ada and a young daughter to keep house. During the forenoon the two girls closed up the house and went to the fields, a short distance away, to gather berries. Near noon they returned and were surprised to find the house-doors open and some noise being made as though some one was in the house. Ada was a brave girl and knew how to handle fire-arms, but as she had none with her she went to a neighbor's and borrowed a six-shooter, loaded, and sending her young companion to her (the little girl's) father's for help, she went to the house. The rest of the story is only theoretical. Upon the arrival of Mr. Jacob Troxell, whom his little daughter had brought, he found Ada lying upon the porch, just outside the door, with a bullet hole in her right breast and in the agonies of death. She did not regain consciousness and died in a very short time, without being able to tell who did the deed.

Mr. Jacob Troxell hearing a wagon driving on the road, hailed the driver, who proved to be Mr. John Washburn, liveryman of this place. He secured his team and went to the house just in time to witness the poor girl's last death struggle. An examination of the premises, showed a bullet hole on the inside facing of the door frame, another in the right breast of the victim and the revolver she had borrowed lying on the porch with three chambers empty. The theory is that the burglars had knowledge of the absence of the family and had watched until the girls left the house when they entered for plunder. They failed to find some money which had been secreted in a safe place but broke open a trunk from which they took a gold watch which was found on the floor smashed as though it had been dropped and tramped upon. It would seem from this that the girl returned to soon and surprised the burglars, and it is supposed that when Ada got to the door she fired one shot at them and that her revolver was wrested from her, and the first shot at her struck the door facing, and the next struck her as stated, at very close range as her dress where the ball entered was burnt by the powder. Aside from this her dress was not disarranged.

News of the tragedy was sent to the picnic and Mr. Perry Troxell and some neighbors hastened home to find the poor girl dead and her body being kindly cared for by the neighbors. Two men, apparently tramps, had been lurking in the neighborhood for several days and the evening before the murder had been to the house for something to eat and remained about the premises quite awhile when they left. Two men answering their description have been traced from near there on Thursday afternoon, going toward Fallen Timber. They avoided that place and crossed a cornfield to the road to Coalport. At Flynnton they stopped at Chaplin's hotel and had some drink, walked on to Coalport, had some more drink and something to eat and took the 4:40 p. m. train to Pussutawney. Their trail was followed by the officers and they were arrested and held at Pussutawney. These two suspects passed through here this afternoon on the Bell's Gap road in charge of officers and have been identified here by citizens and proved to be not the parties that are wanted. Mr. Troxell is a man of means and will spare no expense to ferret out the assassins. Feeling against the murderers runs very strong and if caught and their guilt clearly established Judge Lynch will no doubt save the county of Cambria the cost of a criminal trial.
