A DISTINGUISHED CAREER.

The Most Cordially Hated Man in Public Life.

## STORY OF HIS LIFE'S ONLY ROMANCE.

Twice Defeated for the Governorship of Massachusetts, and Once Elected-Sent to Congress and Mentioned as a Presidential Possibility-His Splendid Record as a Lawyer-How He Wooed and Won His Wife.

WASHINGTON, Jan. 11. - Benjamin F. Butler, the lawyer, politician, statesman and millionaire manufacturer, died at his Washington residence, No. 220 New Jersey avenue, southeast, at half-past 1 o'clock this morning.

The general has always, to a more or a less extent, made his residence in Washington, although many of the scenes of his successful ventures have been located elsewhere. During the present winter a case



which had been decided against him in the highest courts of the state of Massachusetts, and in which he took an appeal to the United States supreme court, has demanded his almost constant residence in this city. Every Monday he was a familiar figure at the sessions of that body on Monday, when the decisions were handed

down. Finally, a few weeks ago, the case was decided against him. Whether or not the loss of the case, to which he had paid such close attention, brought anything more than the sorrows of a casual defeat will not be known.

His death created an immense surprise, as it was not even known that he was alling, any more than any man who had lived and labored so long would. The announcement this morning that he had died at 1:30 from heart failure caused great surprise.

#### AN EVENTFUL CAREER.

Brief Sketch of a Life Spent Under the Light of Public Opinion.

Benjamin Franklin Butler figured in nore characters than any other public man of this age. There have been several abler generals, many more prominent statesmen, as many more eloquent attorneys, though very few as successful and perhaps a few as adroit politicians. But man played so many parts as well,

so much has recently been said, and soon after was removed from command by General Grant.

Of course no prominent American of the era since 1850 has been quite consistent— events moved too rapidly for that. But there is a higher kind of consistency—that of always aiming at the best results—which many can claim; and General Butler always claimed for himself that in each new situation that developed he took that side which he thought best for the laboring Aillions. As an "Old Hunker Democrat" he ran twice for governor of Massachusetts and was overwhelming defeated-it gave



The Butlers came to New England among the first, and Ben's grandfather, Captain Zephaniah Butler, fought under Wolfe at Quebec and gained fame in the revolution, while his father, John, was a captain in 1812-15. His mother came of the Cilleys, a Scotch-Irish family, and the Cilley of New Hampshire who was killed in the noted duel was a cousin of the general.

He was born at Deerfield, N. H., Nov. 5 1818; was graduated from the Baptist col-

lege at Waterville, Me., in 1838, and was in no long time admitted to practice at the bar; was married in 1843 to Miss Hildreth. and became a general in the Massachusetts militia in 1860.

May 13, 1861, General Butler took posses sion of Baltimore, finding the late turbulent city as quiet as Lowell, and three days later he was commissioned major general of volunteers commanding the department of eastern Virginia, with headquarters at Fortress Monroe. There he issued the famous order, or decision, that "as slaves are property in Virginia, fugitive slaves who enter our lines are contraband of war," and many a year passed before the freedmen reased to be called "contrabands."

March 23, 1862, the so called "Butler exedition" reached and took possession of Ship Island; April 17 it started up the Mis-sipsippi, and May 1 took formal possession of New Orleans. For the next twenty nonths General Butler was the most talked about and most thoroughly hated man in America. He has undoubtedly been threatened with sudden death oftener than any other man in the world, except the czar of tussia, but verified the proverb by living

In all the life of the man there seems to have been but one romance, but it was a deep and thrilling one, and, as is the case with most matter of fact persons, it concerned his marriage. In the autumn of 1843 he visited Cincinnati, to find theater goer somewhat excited over the announcement. that a lady of surpassing beauty and many accomplishments would make her first ap pearance at the new theater just opened by Dandy Foster and Ned Chippendale. Butler went, saw and was entranced, and for two weeks nightly occupied a box in the theater.

Finally he secured an introduction to the charming singer, who was a Miss Hildreth. daughter of a highly respected Episcopalian clergyman. His wooing progressed rapidly to a favorable conclusion, and Mrs. Butler remained a devoted wife as long as she lived. She went with him to New Orleans and did much to mitigate the evils of the situations, both while the troops were on Ship island and after the occupation of the city. Their daughter Blanche inherited her mother's beauty and grace. Their son Paul is a happy mixture of both par-ents. During the last illness of Mrs. Butler some years ago the general left nothing undone to restore her, but in vain. He suffered intense pain for hours from the spasmodic action of the heart, and his condition was be such last night as to cause the gravest anxiety of his friends, some of whom were hastily summoned. Shortly after midnight he sank into a comatose condition, and at & o'clock this morning death came to his relief.




