Thirty-seven Killed in Washington State and Two in Pennsylvania.

SEATTLE, Wash., Aug. 25 .- A terrific gas explosion occurred in breast 62 on the sixth level of the Franklin mine, near this city, yesterday afternoon. A number of miners were imprisoned and thirty-seven were killed. The fire was soon extin-guished, and the work of taking out the bodies began. All were recovered.

In all about seventy men were at work in the sixth level north, and of that number about forty lingered at breast 62, where the fire originated, and made an attempt to put it out. The breast was burning fiercely, and before the miners knew it the fire had communicated to breasts 60 and 61. Several of those who lingered at the burning breast, 62, took warning, but all who remained were overcome and asphyxiated.

ASHLAND, Pa., Aug. 25.-Two men were killed and eleven injured by an explosion of gas in the Gilberton colliery, operated by the Reading Coal and Iron company, near this city, yesterday afternoon. The killed are: Frank McCormick, fire boss, of Shenandoah, aged 45, leaves a wife and five children; Lewis Ball, driver, of Shenandoah, aged 19.

The explosion was primarily caused by a fall of coal, which became dislodged by the mining operations. This released an immense volume of gas, and at the same time forced it along the gangways to a distance of more than a thousand yards, stifling and choking the miners as it swept along. Finally it reached a gang of miners, who were working with naked lamps, and instantly ignited.

Rescuing parties were quickly organized, and the men were brought to the surface as rapidly as possible.

Lived a Double Life.

CHICAGO, Aug. 27 .- Two desperadoes held up a Chicago, Milwaukee and St. Paul freight train just over the county line, killed Railroad Detective Patrick Owens, and robbed the conductor and escaped. Officer McGrath was probably fatally shot while trying to catch them, and a force of police and civilians only captured them in a woods after the exchange of a hundred shots and a six hours' chase. The desperadoes are H. E. Griswold and Will Lake. Griswold is a well-to-do local inspector of an insurance company, who it is now believed has been concerned in many other robberies. Lake is a mechanic out of work.

They Played with Dynamite.

TUNKHANNOCK, Pa., Aug. 29 .- One boy was killed and another horribly injured as the result of playing with dynamite near this village. Alexander Preston was digging a well on his farm in North More land township, using dynamite to blast away the rock in the hole. One stick of the explosive became wet, and he put it on a nearby rock to dry. Harry Preston, 16 years old, and Lee Preston, aged 7, two of the farmer's sons, amused themselves by exploding the dynamite by dropping a stone upon it. The force of the discharge threw Harry a distance of fifty feet, kill-ing him instantly, while Lee's head was crushed by flying rock. It is reported that he has since died.

DENVER, Aug. 29. — A warrant was issued last evening for the arrest of Governor Davis H. 



I will not give bail. You may send me to jail, but I will not give ball." Finally the commissioner accepted Gov-ernor Waite's personal recognizance in the sum of \$100 to appear for trial.
