



Putting that Little State in His Vest Pocket Philip Yorks, Milesburg. Was a Mistake-A Good One on Our Dan Not His Time to Laugh.

The Philadelphia Times says: "There nor Garb-Bill-Hastings' visit to the Atlanta exposition which deserves to be printed. "General" Hastings made a speech at one of the gatherings, in the course of which he dwelt in a clumsy sort of way upon Pennsylvania's greatness. With extreme bad taste and manners he spoke disparagingly of all the states represented at the exposition, and coming to Rhode Island, sneeringly said, "Well I'll just put that state, in my vest pocket."
