#### DEMOCRATIC PRIMARIES, ETC.


The Democratic voters of Centre county will meet at the regular places for holding the general elections in their respective election districts, on Saturday, June 1st, 1901, to elect delegates to the

three days, and the children had to be carried. Matters, however, went so well with the sick as to be a cause of surprise. All they required was a drink made of the large Sarsparilla, which proved efficacious in bringing out the eruption." The early inhabitants of Centre and Clearfield counties always supposed that it was smallpox and not the measels which afflicted the migrating Indians. This idea was so firmly impressed upon their minds that they were afraid to open any of the graves along the trail lest they might contract the loathsome disease, notwithstanding the great num-

ber of years which have passed since the victims were buried. In summing up his chronicle, Rev. Ettwein says : "The milk supplied by the cows, which had excellent pasture, went far toward our daily support. Scarce a day passed but what we could distribute rations of meat. True, we heard constant complaints that there was no flour, nor corn, nor beans, but never did a soul go to bed hungry, and those who had aught shared it to the last crumb. \* \* \* That peace and unity should have prevailed in our emigration, was a matter of special gratitude. It is true, at times there were indications of the old feeling, or opposition, inborn in the Mohicans towards the Delawares, yet no contention between the brethren came to our notice. They deported themselves towards each other in a truly fraternal way, and assisted

each other where they could. The Lord be praised for this a thousand times. He helped us in all things to the place to which he brought us."



Not satisfied with stuffing the ballot boxes and padding the registration list in the large cities to carry elections by frauds, these villians now resort to the same methods in the balls of legislation to pass laws and resolutions that were actually voted down! How long will the people submit to these infamous wrongs?

#### ANTI-OLEO BILL PASSED.

The Snyder-Harris Oleo Restriction bill, which had passed the House, was passed finally in the Senate by a vote of 41 against only 1, Senator Magee, and now goes to the Governor. Senator Muchlbronner exclaimed to the Senate that he would not vote, because he was interested in the business affected by the bill.

Senator Snyder says of the bill : "Of the several clauses which effect the interests of the farmers of the State the first is the color clause, which forbids oleo from being colored in imitation of yellow butter and fixing fines and penalties for violation thereof. The second feature of the bill prevents dealers from selling oleo for butter until their cases have been decided by the Courts. This feature of the bill is very similar to the New York law, which has been so effectual in suppressing the sale of oleomargarine.

"The third fetaure of the bill lets onehalf of the fines go to the informer, as under the law of 1885 providing for the suppression of illegal traffic of oleomargarine. The bill provides also for a license which each dealer of oleo must obtain from the Agricultural Department before being permitted to sell the substance. The penalties for violation of the act are similar to those in other States that have succeeded to a great extent in suppressing this fraud."


