


Acceptance of Rockefeller Gift Defended

Notwithstanding objections of the Congregational ministers from all sections of the country the American board of foreign missions has decided unanimously to accept the gift of \$100,000 from John D. Rockefeller. The protesting clergymen had a hearing before the prudential committee at Boston, but were told that a part of the money had already been received and sent on its way to aid various educational enterprises abroad. The donation had been placed in the building and equipment fund.

The committee announced that acceptance of the money was in keeping with the custom of the church to receive upon its altars "the gifts of all who are moved to lay them there." The report also contends that "the acceptance of a gift involves no expression of opinion on the part of the committee as to the character of the givers." It explains further that this policy rests on the belief that gifts to the church "can be accepted only upon the assumption that they are debts paid to God and humanity and involve nothing whatever in the way of favors." The committee believes that there are other and better ways to strike at any existing evil in our country. The Rev. Dr. Washington Gladden of Columbus, O., moderator of the Congregationalists, announced his purpose to organize the churches against the acceptance of Rockefeller's money.

Dr. Gladden's objection he stated frankly, saying that "the money does not belong to the man who gives it." Replying to this, H. H. Rogers, vice president of the oil trust, defends Rockefeller's methods by saying rebates were legal before the interstate commerce act was passed.


