

Receipts and Expenditures OF CENTRE COUNTY FOR 1909

To the Honorable Ellis L. Orvis, the Judge of the Court of Common Pleas of Centre County and State of Pennsylvania: The Board of County Auditors, H. B. Pontius, of Bellefonte Boro; R. D. Musser, of Gregg Township, and C. U. Hoffer, of Phillipsburg Boro, met at the Court House, January 3rd, 1910, in accordance with the provisions of the Act of Assembly in such cases and provided, to audit the accounts of the different officials of the county for the year 1909. Written notices were served on the County Commissioners, County Treasurer, Prothonotary, and Sheriff to deliver all books and vouchers pertaining to their respective offices for examination and audit.

We therefore respectfully submit the following reports, to wit: The accounts of James Woodring, H. E. Zimmerman and John L. Dunlap, County Commissioners; G. G. Fink, County Treasurer; A. B. Kimpfort, Prothonotary; and W. E. Hurley, High Sheriff, were duly examined and found to be correct. The books of the County Commissioners show an expenditure of One Hundred and Sixty Thousand, Nine Hundred and Ninety-Two and 81-100 Dollars (\$160,992.81), paid out during the year 1909. The account of Geo. G. Fink, County Treasurer, was carefully examined, checked, compared with vouchers and found to be correct; and the receipts of the office exceed the expenditures, leaving in the hands of the Treasurer a balance of Forty-Eight Thousand, Three Hundred and Sixty-Four and 14-100 Dollars (\$48,364.14), due the County.

We also find there was collected during the year the amount of Eight Thousand, Two Hundred and Sixty-Three and 66-100 Dollars (\$8,263.66), arising from Unseated Land Taxes and paid out to the different Townships for Road, School and Poor purposes, and in the hands of the Treasurer a balance of Sheep Funds of Three Thousand, Three Hundred and Seventy-Four and 34-100 Dollars (\$3,374.34), arising from Dog Tax. We find there was collected during the year 1909 Three Hundred Dollars (\$300.00), arising from Liquor Licenses for 1909, and was paid out to the different Boroughs and Townships. Upon examination of the bill of fees, costs, etc., of A. B. Kimpfort, Prothonotary, we find there is due him from the County the sum of One Hundred and Seven and 35-100 Dollars (\$107.35). The account of W. E. Hurley, Sheriff, was carefully examined and found to be correct, and find there is due him from the County the sum of Eight Hundred and Forty-Nine and 62-100 Dollars (\$849.62).
