But soon afterward headwinds were encountered and between headwinds and dead calms the Adams would have made but little progress had it not been for her auxillary engines. In fact, progress was so slow that it took the Adams sev-enty-one days to get home from Madeira. Of this time three days were spent at Bermuda, where coal and pro-

visions were procured.

All salable remnants of the \$2,000,-00 National Public Utilities Corporation swindle, of which Governor-elect John K. Tener was president, was sold by a constable on Thursday last in Philadelphia, to satisfy a claim of \$458 for office rent.

Neither John K. Tener, who on the stump expressed great confidence in corporation and publicly lauded its phantom Oregon railroad enter-prise, nor any of Tener's representatives was present at the sale, as far as could be learned.

The announcement of the constable's sale made it plain, of course, that Mr. Tener's campaign confidence in the \$2,000,000 corporation swindle was not backed by the \$458 needed to prevent the constable's sale.
