





The accident happened about home 11:15 o'clock when the youth attempted to run across the Bellefonte-Pleasant Gap highway from the rear of a parked car. As he darted across the road he was struck by the right headlight of a car driven by Henry J. McChesney, of 210 S. Allen street, State College, who was traveling toward Bellefonte.
