11 Cases Heard By Judge Walker

Game Protector Samuel Reed, of Pine Grove Mills, after the officer had arrested the man on a charge of hunting after 3 p. m. The scuffle ensued in Armor's Gap, near town, when Reed allegedly asked the hunter to turn over his gun to the officer. The defendant told the court that the officer did not identify himself properly and claimed that the officer struck first. Other witnesses who testified included Game Protector Thomas Moser and John Tressler.

Fred Dickey, of Beech Creek, was found not guilty of participation in the killing of a deer out of season. A justice of the peace had held Dickey after game officials charged that he took part in shooting a deer with the aid of a spotlights from a car in the Marsh Creek area, November 24.

A case involving a member of Jehovah's Witnesses, a religious sect, was continued for further argument. Briefs in the matter are to be prepared by the defense attorney and by the District Attorney for the further consideration of the court.

The defendant was Hattie K. Meyers, of Lewistown, who was arrested by State College borough authorities on a charge of soliciting funds without having first obtained a license. Mrs. Meyers testified that she had not solicited funds but said that persons had the privilege of contributing to the cause if they so desired.

Mrs. Grace Wagner, of West Posters Avenue, State College, testified that the Lewistown woman had come to her door, left pamphlets, and asked for funds. When asked under what authority she made a door-to-door canvass, Mrs. Meyers said her work was unselfish and not of a commercial nature, and quoted passages from the Scriptures as her authority for her acts.

Mrs. Elizabeth Carmack and Mrs. Helen Caldwell, both of Philipsburg, were directed to post bonds of \$300 each to keep the peace after a case in which Mrs. Carmack was tried on a charge of assault and battery and threats. She was found guilty of the assault and battery count.

Theodore Catherman, of Moore Run, and Carl Vernon Smeal, of Morrisdale, were directed to contribute to the support of their minor children at the conclusion of hearings in their desertion and non-support cases. Lloyd Houtz was denied an appeal for a discontinuance of an order of support against him.

W. J. Tucker, of Pleasant Gap, found guilty by a justice of the peace of making an improper pass on a nearby highway, appealed the case to court, and Judge Walker discharged the defendant because of lack of sufficient evidence.

Fred C. Lucas, of Bellefonte, was denied an appeal from a summary conviction on a charge of reckless driving, and was directed to pay the penalty imposed by a justice of the peace.

Say Mother Killed Baby

hearing before Alderman Brungard.

Voluntary Confession Mrs. Diehl's hearing occurred after she had been taken over the route she said she followed June 20, the day her baby was born. She was in charge of District Attorney Burrill I. Haug, Private Wallace F. Ely of Williamsport, and Corporal W. G. Warner, of Milton, both members of the State Motor Police.

She made a full and voluntary confession of all the events leading up to and preceding the act on which the authorities have based a first degree murder charge. A charge of concealing the death of a child had previously been placed against her in Union county and she was released on bail.

The Motor Police at Williamsport called November 23 to investigate the finding of the suitcase containing the decomposed body of an infant under a summer cottage near Hartleton, found that the cabin had been leased to Mrs. Diehl by the owner. This clue led finally to her arrest on the charge of concealing the death of an infant. Continued questioning resulted in her full confession that, after a fruitless search for shelter for her baby born unattended in her automobile at a spot in the mountains near Hyner, she smothered the infant with two pillows and then placed it in a suitcase, making sure it was dead.

She knew, she stated in her confession, that if she returned to her job at the Laurelton State Village with a baby, she would be discharged, so in her frenzied and confused state of mind she suffocated it. It was not until July 3, over two weeks after the baby's birth, that she secreted the suitcase under the cottage when she was unable to find implements to dig a proper grave for it. She intended to return to the cottage and bury the body, but never did.

Investigating officers were in Lock Haven last Wednesday, clearing certain angles of the case and interviewing the woman's parents, Mr. and Mrs. R. H. Bennison, who live on a farm near Jacksonville. The officers knew her whereabouts and went to her home at Hartleton to make the arrest, after completing their preliminary investigation.

The Motor Police said the woman admitted she had smothered the infant with two cotton pillows, stuffed the body into a suitcase, and after carrying it around for a fortnight, left it under a summer cottage in Lewis township, Union county. She said the baby was born June 21 and the body left at the cottage July 3.

The tiny form, fully clothed and lying on a cotton pillow in the suitcase, was found there a week ago by a party of hunters.

Mrs. Diehl was taken into custody shortly thereafter and charged at the Union county court house, Lewisburg, with concealing the death of a child. She was released then in \$500 bond.

Arrested with her at the same time on a morals charge was John M. Wheeler, 34, also of Hartleton, who pled guilty at Lewisburg and posted \$200 bail for the next session of Union county court.

Officer Ely said Mrs. Diehl told him she had lost her job at Hartleton and set out June 20 to visit a daughter, who is being cared for at the home of the grandparents near Jacksonville. On the way, she related, she became ill. Park-stricken, she drove to Lock Haven and then turned north to Renovo over a mountain road, about half-way between Lock Haven and Renovo.

She asserted she gave birth there to a son without medical attention on the following day, June 21. Then she returned to Lock Haven to purchase new clothes and some wearing apparel for the baby the same day, according to her statements early this morning.

Later she went to the home of a friend where she hoped to leave the child, but found no one at home. Returning to the spot where the baby had been born, she smothered her three-day-old son with pillows in a moment of desperation. Worry over the loss of her job, family troubles and financial difficulties added to her stress, she told the Motor Police.
