

School Board Asks Stock to Resign

Laws regarding sabbatical leaves, and that she took the leave in order to study for her master's degree at Penn State, for the purpose of better equipping herself for her profession.

4. To exclude from Monday's meeting everyone but the school directors of outlying districts who had been invited to attend, and newspapers. (This roster included a number of Bellefonte citizens who were present, together with Earl K. Stock, supervising principal of schools.)

5. To exclude Mr. Stock from attending the meetings of the school board.

The requested resignation of Mr. Stock was broached in a motion presented by Mr. Brouse just as the session was drawing to an end. Schad seconded the motion, and Mr. Hartman demanded to know on what grounds the resignation was requested.

Mr. Brouse replied that it wasn't necessary to state any grounds. Mr. Hartman then declared that in such matters all board members have a right to be fully informed. He criticized what he termed the

growing practice of board members to "pull pre-conceived motions out of their pockets." Mr. Moore said that Mr. Brouse no doubt thought his motion was made for the well being of the school district. The vote showed Hartman and DeHaas opposed to the motion.

The motion to ask Hunter & Caldwell to cancel the contract with the board was made by Mr. Schad. Mr. Brouse seconded it. Again Mr. Hartman asked on what grounds the move was being made and Mr. Schad expressed some opinions. The 3 to 2 vote carried the motion.

Mr. Schad made the motion calling for a notation on the minutes of Miss Barnhart's reputed failure to ask the board for a sabbatical leave, with Mr. Brouse seconding the motion. Mr. Hartman, presenting the teacher's letter in which she assured the board that she would adhere to the provisions of the State School Code regarding such leaves, asked why a teacher who was trying to better herself in her position should be placed in a bad light by the board.

Mr. Schad made, and Mr. Brouse seconded the motion to exclude outsiders from the meeting on the grounds that interruptions would delay the conduct of business. The motion also carried the stipulation that before leaving, the citizens and

visiting school directors were to be given a total of 20 minutes to bring any matters before the board. Mr. Brouse recommended extending the total time to 45 minutes, and Mr. Hartman objected to the motion on general principles, expressing the belief that visitors should be entitled to stay if they desired. The motion was carried by the 3 to 2 majority.

After the passing of the latter motion, which came early in the meeting, the session adjourned to the Academy auditorium so that all visitors could participate in and hear the 45-minute discussion. It was after that 45-minute time expired that all the other moves outlined above, as well as the one excluding Mr. Stock from meetings, were made and passed.

The exclusion of Mr. Stock came to a vote when Mr. Hartman moved that the supervising principal be notified to attend board meetings. Mr. DeHaas seconded the motion, which was defeated by the 3 to 2 vote.

Members of the school boards of various outlying districts had been invited to attend the meeting to express their views on the non-resident pupil problem in Bellefonte. The consensus of feeling among the visiting directors seemed to be that they earnestly desire to continue

sending their pupils to Bellefonte, and would be glad to help in any way possible to bring about that continuation. All but two small districts reported that they are in serious financial condition and could do little or nothing toward aiding financially in the construction of a new school in Bellefonte. The Pleasant Gap representative reported that the attitude of the Bellefonte board in recent months has set up such a barrier that a consolidation proposal could not be "sold" to Spring Township citizens at present. "What we want is concrete figures and a definite program for a building and for consolidation," he said.

Other representatives praised the Bellefonte High school for its efficient administration and for the

high scholastic record it has maintained for many years. One director said, "We consider the Bellefonte High school one of the best in the State." As a result of the discussion of the outside-pupil situation, it was voted to secure the services of the department of public instruction at Harrisburg to make a survey of the problem and the needs which would have to be met in case of possible consolidation of Bellefonte and outlying school districts. A request will be made to the state to have a complete survey made of the size of a building, the number of teachers necessary, and all matters which will throw light on helping to solve the present problems.

In accord with action taken at a previous meeting, the board after

considering bids upon a financial survey of the non-resident pupil costs to the district, unanimously voted to retain C. J. Roland and Company, State College, certified public accountants, to make a study of the problem. The survey is not to cost in excess of \$200.

The newly formed Association of Public School Teachers of Bellefonte Borough presented a request to the board to hold meetings at 3:15 p. m. the first Monday of each month. Action on the matter was tabled. The secretary of the organization, in a letter to the board, explained that the purpose of the group is to promote co-operation between teachers and school directors.

The resignation of Miss Mary Wolka, high school physical education teacher, was accepted, and Miss Gergette Purnell, of Bellefonte, was named as substitute until a permanent appointment is made. Miss Wolka has accepted a position in the Lebanon Junior High school at an increase in salary, it was reported.

The board granted Mr. Stock an allowance of \$40 toward his expenses in attending an educational convention to be held in St. Louis late this month. Mr. Stock indicated that the total expenses of the trip will be about \$75, and that he will personally make up the difference.
