Russell W. Dunlap, 48, of North Side, Pittsburgh. The two men and several companions left the Port Matilda Hotel at daybreak on the morning of the fatality and had been hunting only a short time when Woodring spied a movement in the woods.

The bullet entered Dunlap's chest, killing him instantly. During the trial it was brought out that Dunlap wore no red markers on his clothing and that he was "out of scheduled position" on the drive being conducted by the group. It was testified that the early morning darkness was further heightened by overhanging trees and that the sky was overcast with heavy clouds.

Woodring claimed that he was sure he was shooting at a deer, and that a companion nearby also believed that to be the case. It was further testified that he was hunting for approximately 40 years and has never been involved in an accident before.

The case aroused considerable interest among spectators and court attendants alike, many of whom held strong opinions as to the justice of the laws regarding such hunting accidents. Two pleas of guilty were heard during the two-day session of court.

Joseph Rushnock, of Snow Shoe township, pleading guilty to a charge that on December 15 he sold beer without a license, was sentenced to pay the costs of prosecution, a fine of \$300, and serve 3 months in the county jail. J. W. Barefoot, of the State Liquor Control Board enforcement squad, was the prosecutor.

MARCH 1 DEADLINE FOR 1940 DOG LICENSES

operating through State College, related with the announcement of the purchase of the Foster Coal property next to the Bellefonte Central yard on North Alherton street, and the declaration that Greyhound would erect its own bus depot there.

The plaintiffs in the injunction proceedings, Harper, Holmes and Kennard, in their bill of complaint to the court recite through their attorneys, Fleming & Licks of Bellefonte, the following contentions:

That College avenue is part of State Highway Route 45 and is the principal thoroughfare through town, being bounded almost entirely on one side by the Penn State campus.

That College avenue affords a maximum degree of convenience to students, residents and visitors as affecting their arrival and departure by bus.

That hotels, restaurants, comfort stations and other facilities for the traveling public are principally found on College avenue.

That the enforcement of the new ordinance causes extreme and irreparable damage to the public in general and is unduly oppressive on the individual public.

That the ordinance is contrary to the provisions of laws requiring that ordinances be reasonable and uniform in operation.

In conclusion the plaintiffs ask the court that the defendants be required to appear in court to answer the bill and abide by the decree of the court, and that the defendants be restrained from prohibiting and preventing the stopping of buses on College avenue for the loading and unloading of passengers and baggage.
