## MRS. HANNAH H. LUTZ

Mrs. Hannah H. Lutz, 87, a native of Rebersburg who has been making her home with her son, Irvin Lutz, at Jersey Shore, died at the latter's residence Monday evening, March 3, 1941. Surviving besides the son, Irvin, are two other sons, John R. Rochester, N. Y., and Harry, Lansing, Mich.; three daughters, Mrs. Meta Stabley and Mrs. Clair Lauer, Williamsport; Mrs. Mary Lair, Salona; 11 grandchildren and eight great-grandchildren.

## TOBIA PLOZNER

Tobia Plozner, well known Buffalo Run Valley farmer and former employe of the old Centre County Lime Company, died at 11:30 o'clock Monday morning, March 3, 1941, at the Centre County Hospital after a two weeks' illness with influenza. He was admitted to the hospital a week before death, but failed to respond to treatment. Mr. Plozner was a son of Tobia and Orsola Plozner and was born in Italy on April 27, 1887, making his age at time of death 53 years, 10 months and 4 days. His wife, the former Orsola Mentril, passed away in July, 1939. Surviving are these children: Tobia, Jr., Angelo, Mary and Virginia, all at home, and a brother and sister, John Plozner, of Bellefonte, and Mrs. Angelo Mosler, residing in Italy. He was a member of St. John's Catholic church, Bellefonte. Funeral services will be held at 10 o'clock this Thursday morning at St. John's Catholic church, Bellefonte, with the Rev. Father William E. Downes officiating. Interment will be made in the Catholic cemetery, Bellefonte.

## MARTIN MCGOWAN

Martin McGowan, highly esteemed and oldest resident of Moshannon, passed away at his home there Wednesday evening, Feb. 26, 1941, at 6:15 o'clock of complications due to advanced age. Mr. McGowan, who spent all his life in Moshannon, was interested in lumbering during his younger days, and for the last 50 years conducted a blacksmith shop there. He was 82, and the last surviving member of his family. Mr. McGowan was born in Moshannon, September 28, 1858, a son of Patrick and Honorah McGowan, of County Clare, Ireland. His wife, the former Margaret Flanigan, died February 16, 1939. At the time of her death they were the oldest living couple of St. Mary's parish, both being very active in the running of the present church structure, and their parents were instrumental in the founding of the first Catholic church for the St. Mary's parish, Snow Shoe. The following daughters survive: Misses Clare and Ann, at home, and Miss Mabel of State College. Funeral services were held Saturday morning at 10 o'clock, with the Rev. J. P. Connelly officiating. Interment was made in the family plot in the St. Mary's cemetery, Snow Shoe.

## E. BEACH SCHREFFLER

E. Beach Schreffler, of East McKeesport, native of Zion and for forty years an employe of the Westinghouse Electric and Manufacturing Company, died at 6 o'clock Saturday night, March 1, 1941, in a McKeesport Hospital 12 hours after he had suffered a cerebral hemorrhage. Mr. Schreffler was an engineer for the Westinghouse Company and about ten years ago was sent to Chile to supervise the installation of the first electric railroad in that country, being located in that country for more than two years. He was a member of the I. O. O. F. lodge at Wilkesburg and was a member of various other organizations. The deceased was a son of Albert and Mary Twitmyer Schreffler and was born at Zion on July 29, 1881, making his age at time of death 59 years, 7 months and 2 days. He was never

married and is survived by a sister, Mrs. Phillip Pate, of East McKeesport, with whom he made his home, and a brother, Robert B. Schreffler, of Chicago. Miss Joanna Decker, of Bellefonte, is a full cousin. Funeral services were held at the Pate residence in McKeesport Monday night, with the Rev. D. Lester Bay officiating. The body was brought to Zion where further services were held Tuesday afternoon in the Zion Reformed church, with the Rev. C. Nevin Stamm, pastor of the Bellefonte Reformed church, officiating. Interment was made in the Zion cemetery. Mr. Schreffler spent his boyhood years in the Zion area and was quite well known locally through visits with relatives in this part of the country.

## JOHN C. FABER

John C. Faber, well known retired Pennsylvania railroad freight station clerk, who made his home with Mr. and Mrs. David Jones, Altoona, died at 9:25 o'clock Monday night, March 3, 1941, at the Altoona Hospital after an extended illness. Born June 3, 1865, at Pine Grove Mills, Centre county, he was a son of John C. and Sarah (Nicholas) Adams Faber. He retired from the employ of the railroad company six years ago. He is survived only by one half-brother, Harry Swoope Adams, of Tyrone. Mr. Faber was a member of the Grace Methodist church and the P. O. S. of A.

## MRS. MARY HEMINGWAY

Mrs. Mary Hemingway, widow of the late William Hemingway, Middletown, N. Y., died Monday night, March 3, 1941, after a lingering illness. She was a daughter of Judge Samuel Linn who presided as Judge at Bellefonte and later practiced law in Williamsport. She was a granddaughter of the Rev. James Linn, for many years pastor of the Bellefonte Presbyterian church, and she was a descendant of James Harris, founder of Bellefonte, and other early settlers of this area. Surviving are a sister, Mrs. Howard Charney and niece, Mrs. George Sanders; also a daughter, Edith, at home; a son, Samuel Linn Hemingway, Newburgh, N. Y.; a brother, Herbert Linn, Arlington, Va. Services will be held at the First Presbyterian church, Middletown, at 2 o'clock on Thursday afternoon, with interment there.

## Name Marshall SPCA Agent in County

Bellefonte Borough Dog Law Enforcement officer, James G. Marshall of West Lamb street, this week received notification of his appointment as agent for the Pennsylvania Society for the Prevention of Cruelty to Animals, with jurisdiction in Centre county.

Although the post carries no remuneration, the society pays fees and expenses in cases where violators are convicted of crimes against animals.

The motto of the society are "Consider the Man as well as the Beast" and "Prevention Rather Than Punishment." Marshall is urged to bring about enforcement by appeals to reason rather than by legal action, although the latter course is recommended where violators ignore warnings or requests. Headquarters of the state society is in Philadelphia.

## Undines Receive Emergency Truck

The Undine Fire Company yesterday received its new emergency truck—one of two units recently purchased to replace the present Ford pumper.

The new truck, with a specially built body, was driven from the body works at Altoona yesterday by these members of the company, Vincent Flynn, Guy Glenn, Paul Emerick, and John O'Leary.

The machine has a cab which seats 10 men and which can seat 12 with a little crowding. It will be used principally to carry men and equipment, such as boots, coats, lights, resuscitating equipment and other accessories.

The pumper unit is expected to be delivered about March 15. Both trucks are mounted on Ford chassis. The present Ford pumper is to be sold to the Milesburg Fire Company.
