Y Approves New Bowling Alleys

Construction of Addition Depends on Ability to Secure Structural Steel

Although approval has been granted by the Y. M. C. A. board of directors for the construction of new bowling alleys, the project will be delayed indefinitely, it became known here this week.

The house committee of the "Y," after consultation with architects, decided that the only suitable location for a new series of alleys would be above the swimming pool, since that part of the building is only one story in height and is large enough to provide accommodations for six regulation alleys without disturbing any other activities of the Y.

In preparing plans for the improvement, it was found that steel girders would be necessary in building the alleys over the pool and it also was found that since it is virtually impossible to obtain structural steel because of the national defense program, plans had to be halted for the time being.

The committee, however, has the authority of the board of directors to proceed as soon as materials become available.

The new addition would provide space for six more alleys, which with the present four in the rear portion of the building, would give the local Y a total of ten alleys.

William B. Troupe, Dr. E. H. Adams and Mrs. Millard Hartwick won both Democratic and Republican nomination for school director, and since three directors are to be elected in November their offices are virtually assured. James R. Hughes polled 17 Democratic and 69 Republican write-in-votes for school director.

Democratic nominations for Council were: West Ward, Edward J. Treman, 81 votes; North Ward, Charles Schaeffer, 6 votes to defeat Newell B. Long and Thomas Beaver, each of whom received 3 Democratic votes.

Republican nominations for Council were: North Ward, Newell B. Long, 339 votes, and Walter R. Eberhart, 259 votes; West Ward, Harry P. Meek, 62 votes; South Ward, Russell Lambert, 253 votes.

John S. Walker, unopposed Republican candidate for auditor, polled 661 votes in the three wards, and won the Democratic nomination with five votes. In the absence of a Democratic candidate for the office, Clayton Royer, D. F. Houser, and Melvin Cherry each received one vote.

William H. Brown, unopposed Republican candidate for Justice of the Peace in the North Ward, polled 359 votes. Burgess Haradman Harris was assured of another term in that office when he captured both Republican and Democratic nominations. His total Republican vote was 642 and his Democratic vote was 123. The Democrats had no candidate for the office.

Miss Helen Schaeffer received the Democratic nomination for judge of elections in the North Ward, while Mrs. Ana P. Wilkinson was nominated by the Republicans of the ward.

In the South Ward Samuel D. RhineSmith was nominated judge of elections; and James E. Decker, Jr., inspector of elections. Both are Republicans. John Gillen is the Democratic nominee for judge and Mary McCusley Democratic nominee for inspector in the ward.

E. O. Struble received the highest vote in the West Ward for both judge and inspector of elections.
