





Registration for two Adult Eduation courses in addition to those already in operation will be conducted this Thursday night. Octobe 30, in the Spring street school building at 7 o'clock. The two courses will be in fields of blue print read-

ing and elementary accounting. The blue print reading course has been approved under the Defense Training Program. This course will include some work in sketching and drawing for those who are interested in this type of work and will take care of the needs of individuals who are not interested in or do not qualify for the course in drafting now being offered under the Pennsylvania State College Extension Department.

No educational or age require ments need be met for registration for this work. The course is intend-ed to increase the efficiency of men in industry or to better prepare the unemployed for positions in indus-

The course in elementary accounting is being organized under the program of the Department of Pub-Instruction for Adult Education which has been in effect for several years. This course is intended to provide either a basic training in bookkeeping and accounting for those who have not had this type of work or to serve as a review course for those who have had limited training but feel the need of further instruction. All those interested in either one
