2. A charge of two dollars an hour will be made for rehearsal or practice if held in the auditorium or either gymnasium. If a classroom will suffice for this purpose, no charge will be made.

3. An extra charge for janitor service will be made on Saturdays and Sundays, in addition to the regular charges.

4. Practices which tend to cause a dirty or detrimental condition will not be permitted at any meetings or functions held in the schools. A reasonable effort on the part of those granted permission to use any part of the school facilities is required to leave the property in the same condition in which they found it.

Board president Horace J. Hartranft instructed the finance committee to meet with the finance committee of borough council to study property assessments with a view to removing some inequalities which are known to exist.


High school pupils are required to have gym suits, school officials explained to board members, but these suits do not have to be bought from the schools. Such outfits are on sale at the school at \$1.75 each-which is their approximate cost to the district. A gym outfit consists of softsoled shoes of some kind and appropriate clothing.

The board voted unanimously to open the school cafeteria in the new building at the earliest possible time (estimated at several weeks). Mrs. Robert Funk of Hecla, was employed to operate the cafeteria under the supervision of the home economics department. The cafeteria is to be conducted at no profit to the district, the chief aim being to profor students.

Mrs. Rosalie Yearick Blair of Bellefonte, was elected as full-time Church of Christ. board secretary, effective when the needs of the district.


