Rev. Reges F. Canevin, President of the Diocesan Union of the National Catholic Total Abstinence Society, has issued a circular calling a convention of all the local societies in the Pittsburg diocese, to be held in Lafavette Hall March 12. The convention will be attended by about

120 delegates. There are 40 societies in the diocese, and each one will be entitled to three representatives. Included in the business to be transacted will be the election of delegates to the national annual convention of the union, to be held at Cleveland in August next. #### CONSTITUTIONAL AMENDMENT

to a vote of the people in June. It is said that between one-third and one-half of the members throughout the State will vote for the adoption of the amendment. While the others are total abstainers, they will not wote for the prohibitory law. A great many of the members in this city believe in individual prohibition, and take the liberal Catholic view of the matter when it comes to the issue of stopping the manufacture of liquor entirely. An effort will probably be made by some of the radical members at the convention to pass a prohibitory resolution.

Among the prominent people to be present at the convention is the Very Rev. Father Garrigan, Vice Rector of the new Catholic University at Washington, D. C. He will make an address on "Higher Education." Father Garrigan is well known in this city from his writings, and there will be a great desire to see and hear him.


