BIG LAWYERS IN THE RAILROAD TRIAL

Yesterday Superintendent A. B. Starr, of the Fort Wayne Railroad, was placed on trial on the charge of criminal negligence. The case grows out of the killing of Miss Harriet Weyman and John M. Culp at the Federal street crossing on November 3, 1887. Judge Magee was on the bench. Frank R. Gowen, of Philadelphia, formerly President of the Reading Railroad, was the leading attorney for the prosecution. He was assisted by D. T. Watson, J. M. Collins and Clarence Barling, while John S. Robb and Richard Johnson appeared for the defense. The trial was held in the city courts.

THE CELEBRATED ORDERS.
