ALL CHARGES DENIED.

The Civil Service Examination Papers Made Public—Were Obsolete—The Fallows Investigation is Coerced by the Commission.

WASHINGTON, October 5.—Civil Service Commissioner Lyman was seen today and asked if he had anything to say concerning the publication in the morning Washington Post, and replied that his preference was for a thorough investigation by a competent tribunal, rather than any explanation or defense in the newspapers, and that he sincerely hoped that such an investigation would be had. In the meantime, however, and pending such an investigation, he would say the statement that the set of papers given out by Mr. Campbell were current papers, given out in advance of an examination, is untrue. They were papers, he said, that had been previously used and had become obsolete, such as the commission now publishes to the world in its annual reports.

He said, in the investigation made at the time by the commission developed the fact of Mr. Campbell's connection with the transaction, he saw the propriety of his taking part in it, and said so to Commissioner Obery, who concurred with him and thereupon left it to be completed by him, requesting that he get at the bottom of the matter. He subsequently reported to Mr. Lyman what he had found and his conclusion that Campbell should not be reemployed, but reprimanded. "I expressed my satisfaction with his conclusion," said Mr. Lyman, "based upon the statement of the case as made to me by him. This matter occurred nearly or quite two years ago, and has not since that time been a subject of consideration by the commission. I desire," he added, "to make one other statement now, and that is that there has never at any time been an appointment or a promotion made at the office of the commission in violation or evasion of the civil service rules. In every case the rules have been scrupulously complied with, as the records will clearly show."

Mr. Roosevelt said: The charges, in so far as they are directly made, refer to matters affecting the public interest, and in such cases the public has a right to know anything done in the commission since the first of May, when Governor Thompson and myself took office. They should, therefore, be investigated before a competent tribunal, and if they affect the management of the commission under the previous administration, a tribunal should contain Democrats as well as Republicans. In other words, the matter should be investigated by Congress as soon as it meets, and I not only court such investigation, but will regard it as a real misfortune if the commission, the accusations have been carefully put in the form either of insinuation or of some sweeping generalization, so that I shall make sure that those making them do so before a tribunal where they must speak under oath.
