





AN EXPLODING LAMP

The Probable Cause of the Fatal Fire in the Tracy Mausion-A Report Made

After a Careful Investigation. WASHINGTON, February 6 .- Fire Marshal Drew to-day submitted to Chief Parvis his report on the fire at Secretary Tracy's house. The report was forwarded to the District Commissioners. The Fire Marshal BAVS:

In compliance with your request I made a thorough examination of the burned building at 1634 I street, Northwest, owned and oc-supisd by the Hon. B. F. Tracy, Secretary of euplied by the Hon. R. F. Tracy, Secretary of the Navy, and from all the evidence to be gleaned from the hired help in the house and from the surroundings in the library or main room on the first floor, I am of the opinion that, while of course there is no direct proof that this fire originated from the explo-sion of a coal oil lame, a large double-burner duplex lamp being kept on a table within the circleformed by the large bay window, which hamo was lighted every night. It is very likely that when the family retired the night before the fire that instead of exiting uishing the light the blaze was turned down low and left burn-ing, which is a very dangerous practice, as the work is apt to become crusted, preventing a free flow of flame and keeping the heat below the crust, thereby causing the thin brass work of which the burner is composed to become so hand as to generate gas within the bow of the lamp. If the was the cause, as I have every reason in heliers prices of the heat below

lamp, causing it to explode. If this was the cause, as I have every reason to believe, pieces of the lamp being found scattered in different directions over the floor within lines of the bay window, and taking the surroundings into consideration, the bay win-dow being heavily curtained with silk and hace draperics, and in close proximity to the lamp, the three doors leading from this room also having silk portieres, with both walls and cellings heavily coated with hard oil and varnish, It would take but a very short time to envelop the entire room in flames, and it was from the conditions mentioned, a veritable from the conditions mentioned, a veritable fire trap. When the fire was first discovered. fire trap. When the fire was first discovered, the door opening from the burning room into the main hall was closing, as stated by the butler. James Walsh, who passed said door to answer the ringing of the front door bell at which he found a man who told him that the room was on fire. He ran to those doors slid them open, and is satisfied that he closed them mmediately. This cannot be so, as one of the doors was found pushed back into the partition and is hardly smoked, while the other one has the face nearly burned off. In his excitement he failed to close them. The door in question opened almost opposite the foot of the main stairway, up which the fire and dense smoke of the burning varnish rushed, making it impos-sible for anything living to have ascended that stairway. All means of encape was thus cut off from above so far as the front was concerned, and this column of dense smoke took but a few and this column of dense smoke took but a few and this could every room in the house fri the first floor to the roof, no doubt bewilder everyone who came in contact with it.
