WILL NOT BE SOLD.

No Excuse Now for the Sheriff's Flag Over Library Hall.

A Consolidated Mortgage Secured to Cover All Indebtedness.

Library Hall will not be sold. The sale of the property, which was set for to-day, has been started off, and the company will continue to do business at the old place.

This good news will be welcome to the friends of the Mercantile Library, a great many of whom thought the latter would be driven out of the building and left without a home.

The Board of Directors of the Library Hall Company have negotiated a new consolidated mortgage loan on the property, by which they will be enabled to meet all the present claims against them.

On the third mortgage the Library Hall Company paid \$100,000, reducing the third mortgage judgment to \$50,000. The Union Trust and Trust Company of \$15,000, and the Library Association \$5,000.

The company took up the judgment, which has been in the hands of the Sheriff since the original investment, the hall becomes the property of the library.
