It will be two years the 9th of July since Mr. Randall was seized with the dangerous illness which has clung to him ever since

his bouse. The oath was then administered to him by Speaker Reed, that he might draw his pay, and pairs upon political questions have been regularly arranged for him. Most of the time he has been able to read the newspapers and has manifested a keen interest in public affairs, and it is only within three or four days that he has been finally induced to desist from reading the daily papers.
