

THE NEW FIRE RULES.

If the Director Follows Instructions He Will Earn His Salary. MANY NEW ORDERS LAID DOWN.

At the meeting of Councils today Chief Brown, of the Department of Public Safety, presented a paper outlining the duties of Fire Director and Court Officer. These are the two new positions the Chief asks Councils to create.

Rule 1—The Fire Director shall be possessed of, or shall acquire such scientific knowledge as shall enable him to operate the fire alarm system to exhibit by comparison all the different fires that may occur within the limits of the city of Pittsburgh, and he shall make himself thoroughly acquainted with the scientific knowledge of the Chief Engineer and his assistants.

Rule 2—The Fire Director shall have absolute command, control, charge, management, discipline and supervision of every fireman and employe in the Bureau of Fire, and shall have absolute command, control, charge and management of every fire in the city of Pittsburgh, and the Assistant Superintendent in the various districts shall be subject to his command and control at such fire.

Rule 3—The Fire Director shall be responsible for the good discipline, good conduct and efficiency of the firemen of any and all fire companies in the city of Pittsburgh, and shall see to it that the men are properly exercised, that each man knows exactly what his duty is, and intelligently understands the meaning of the signals and strength of the company shall be carefully looked after and that their welfare and efficiency shall, by all possible means be maintained.

Rule 4—The Fire Director shall see that within the city all the laws of the State and ordinances of the corporation of the city of Pittsburgh, which he has cognizance, are being observed, and that the parties above named, each and every captain of every engine house in the city, which meeting shall be held at 10 A. M.

Rule 5—The Fire Director shall see that his office such books of record as shall be prescribed by the Chief of the Department of Public Safety. Among others he shall have a record of the names of the men who are appointed to the various positions in the Bureau of Fire.

Rule 6—The Fire Director shall see that the fire engines in the city are clean and neat, and always in good order; that the men are comfortably provided for; that the company's books are kept in conformity to the rules and regulations, and that the men are faithful to the discharge of all their duties; that they are courteous and gentlemanly in all their relations with each other.

AN OLD-TIME HOAX.

How Ten Thousand People Were Sold, More Than Forty Years Ago. THE CELEBRATED FLYING GOOSE, And the Amusement it Caused at the Hand Street Bridge.

The old Hand street bridge, in recent years called the Ninth street bridge, is rapidly disappearing, one timber after another giving place to iron beams and rods. It is the oldest bridge across either of the rivers here, and is therefore the patriarch deserving respect.

The Hand street bridge was begun in 1837 and completed in 1839, so that it is at least 81 years old. It was built by the late John H. Hand, who was then a resident of the city.
