FINDING OF THE MASTER.

The master finds that plaintiffs' evidence was to the effect that the ore situated on copper ore, containing lead and zinc, was taken from the mine and shipped into the atmosphere, and that the atmosphere was so polluted as to be injurious to the health of the people living in the vicinity, and that the alleged effects of noxious vapors were so destructive to vegetation on Jack's Island that the root decay was allowing the river to gradually erode the island and deposit the soil in the Gulf of Mexico.
