



SENATOR CALL SHOWS HE CAN USE BITTER SARCASM, TOD.

A Lively Wrangle About a Changed Paragraph in the Congressional Record-The Kausas Seanter Charges the Florida Statesman With Abasing His Privilege. WASHINGTON, June 25 .- In the Senate to-day Mr. Ingalls offered a resolution in-Elections to inquire into the publication in the Congressional Record of to-day of a personal explanation by Mr. Call, and to report whether it is in accordance with the rules, regulations and practice of the Senate; and directing that such personal explanation be withheld from the permanent edition of the Record until further order of the

Senate.

Mr. Call said that he did not think that the resolution should be adopted. There was no possible ground or reason for it, and no excuse for it. He had asked leave of the Senate on the 2d of June last to print ex-tracts in the Record in winducation of his career in the Senate, in response to a pamphlet attacking him, and that was all that he had done to day. The libel to which he had been replying had contained a stat-ment of bills which he had introduced in the Senate and which had not become last At his leisure he had prepared a statemer in his own viadioation and had submitt it to a member of the Committee on Prin


