Adeline Moore Charges Her Former Adorer With the Crime.

EXCITING TRIAL AT UNIONTOWN.

The Scale Committee at Scottdale Trying to Reach Terms.

DEATH OF ONE OF OHIO'S PIONEERS

UNIONTOWN, March 10.—Cyrus A. Porter is being charged on the charge of poisoning the sheep and other stock of Miss Moore, who resides near New Salem.

Porter was seen by them at unseemly hours about the premises, and after his visits they were sure to find the poison scattered. At one time 29 sheep died, and when the prosecution began to look for the Moore girls had Porter arrested on suspicion. J. C. Barrett, a chemist, testified that he had analyzed portions of the stomachs of the dead animals and found that they contained blue vitriol and arsenic. Miss Adeline Moore, the prosecutor, was prompted by her refusal to marry him. The two brothers of the Moore girls testified that they had found blue vitriol mixed with oats in the field where the poisoned cattle were.

THE LAST APPEAL. For the Nicerly Murderers Refused by the Board of Pardons.

HARRISBURG, March 10.—The only case disposed of by the Board of Pardons at its meeting today was that of Joseph and David Nicely, of Somerset county, whose execution is fixed for April 2 next. The board was briefly addressed by Mr. Gilbert, of this city, who referred to several affidavits which had been filed as showing that the murderer of Abram Unberger by the Nicely brothers, who were sentenced to hang, and seeking to contradict the testimony of witnesses which went far toward the conviction of the pair.
