

SUICIDE BY FASTING. A Woman's Deep Grief for the Death of Her Favorite Daughter PROMPTS TO SELF-STARVATION. Every Effort to Coax or Force Her to Take Nourishment Fails. THE END COMES ON THE FIFTIETH DAY

PITTSBURGH, June 16.—Particulars of a strange, desperate and successful suicide by starvation come from McConnors, this county, the suicide being Mrs. Harriet Smith, who starved herself to death on account of the death of her daughter, Mrs. Daniel Moser, of the Hotel Anderson. She was 45 years of age, and had been married to her husband only to find that each day brought her nearer death's door.

Mrs. Smith was the wife of John Smith, a man who for a number of years had the reputation of being the wealthiest and most prominent farmer in the valley. Fifty-eight days ago Mrs. Moser, the eldest daughter of the Smiths, took sick. She was her mother's favorite, and her illness gave the family much alarm. After four days of suffering she died, and since then not a crumb has passed Mrs. Smith's lips.

She Announces Her Determination. At first the latter's grief did not assume a morbid form. She was in the habit of attending to the relations she attended to the funeral. As the coffin was being lowered into the grave, Mrs. Smith started, the people around her stating that she would never eat another mouthful of food on this earth. It was supposed that the woman had uttered the words under the immediate stress of grief, and no one believed that she would keep her word.

More New Production. WILDWOOD SHOWING UP WITH A GOOD WELL AND OTHERS DEU. Three Wells in the Sand at Murdock's Hill, and Not Much Above Down—Several New Wells Being Dug—Dana—Activity at Corsopolis and Moon.

Three Light Wells. MURDOCK'S HILL—Gulley & Queen have finished their well on the Murdock hill, and it is showing for a very small well. It will be shot in the hope of making a producer. Squire's well on the Thomas Hill farm has been reported as being almost a duster. Pittsburgh & Co's well on the Dr. Fillmore's place is showing in developments, is through in sand and dry. It will be drilled to the fifth sand.

That Hogher Well. CORNPOLES—The Forest City Oil Company's well on the Hogher, opposite this place, which has been reported as being a dry hole, is showing a flow of oil. It is good for 40 barrels. Mellon's No. 10 on the Kerr, will get the sand this morning. Gulley Brothers have a rig up for his No. 5 on the Mark Watson. Mellon's Nos. 2 and 3 on the Jerry farm are due to get the sand tomorrow. He has a rig up for his No. 5 on the Kerr. The Kerr Oil Company's No. 4, on the Marks farm, was reported as in the sand and showing some oil. The Kerr Oil Company's well on the John McIntyre is on top of the sand.
