Between Two of the Parties in a Now Prominent Divorce Case.

PASTOR AND PEOPLE.

How the Shelving of Experienced Ministers Will Very Often

PROVE DISASTROUS TO CHURCHES.

Some of the Topics to Be Discussed in Our City Pulpits To-Morrow.

GLEANNINGS FROM CHURCH FIRDS

Lawyers and physicians who have reached the half century mile post are considered to be at their best, and with fair ability have little difficulty in securing clients and patients. The minister, as a rule, is on the wane when he passes what is denominated the dead line of 50 years, and has little to show with respect to his work. He is looking out for a young man of brilliant parts. By all ordinary rules the preacher of 50 is better equipped for his work than the one of 25. But congregations are disposed to shelve the former and lionize the latter.

There are many things needed in pastoral work, which can only be learned in the school of experience, and it seems a pity that the best spirit of our young America should deprive the church of the ministrations of those who have gathered the ripe fruits of experience.

When great financial interests at stake consult a ripe lawyer whose experience and practice have given him knowledge which could not otherwise be gained.

"When disease or bodily infirmities begin their work, we want an experienced physician at our bedside. But, in choosing a spiritual physician, we yield to the pressure of young people and join with them in shelving the pastor who has given us our baptismal consecration and who for a generation or more has been identified with our home and church life is better equipped to minister to us than the young man, it usually begins the process of freezing out by cutting down the rations.

When the minister was called many years ago he was very generous in his ideas, and for a time money poured in freely and salary was promptly paid. Brother—was ready to take a half dozen pews if necessary, and the new minister was greeted with the usual "Welcome to our church. But now he is growing old fogey. He is too outspoken. He is behind the times. A younger man of more style would better suit our needs. The pressure for change of dynasties grows stronger day by day. A year or two of this kind of pressure brings a resignation from the pastor who was so popular a few years ago. The church becomes vacant, and the same old process is repeated with a brilliant young man who has his day and ceases to be. There is one thing utterly mean, without one redeeming quality, in the conduct of a church toward its pastor, and that is the starving-out policy.
