Three Other Officials Declare that the Miners are in Danger.

CRIMINAL COURT OPENS NEXT WEEK

A bill in equity was filed yesterday by James Black, Henry Loutin, William Jenkins and William Duncan, mine inspectors, against J. D. Sauters, the mine owner and operator. The plaintiffs state that they are the inspectors for the First, Second, Fifth and Seventh districts of the bituminous coal region of Pennsylvania.

The mine, it was stated, is perforated with seven oil and gas wells, and a large number are in process of being drilled into and through the bituminous coal seam and the gas and oil of the wells drilled through the mine will pass through the mine.

Sauters, and moved 3,000 cords of lumber from the land.
