Whereas, Certain persons, companies, cor-porations and associations own and main-tain in the borough of Glenfield gates hung and arranged to open and swing out and to-ward boardwalks, pavements and streets, and

and arranged to open and swing out and streets, and Whereas, Gates so placed and hung and arranged are liable through negligence or otherwise to be left open and thus obstruct such boardwalk, pavement or street where such gate or gates are located. In fact, gates so hung and arranged have been and are now allowed, through the negligence of per-sons owning, maintaining and using such gates to remain open, thus obstructing boardwalks, pavements and streets, and, owing to the position of such gates, the arrangement and operation of same and re-sults thereoi, they are deemed to be danger-ous to pedestrians and are a public nuisance. Section 1. Be it enacted by the Burgess and Town Council of the borough of Glenfield, and it is i.ereby enacted by the authority of same. They, any and all person or persons, com-panies, corporations or associations now owning or maintaining within the limits of the borough of Glenfield, gates hung or ar-ranged to open or swing out and toward the boardwalk, pavement or street, shall, within ten days from due of notice from the Coun-cil of the borough of Glenfield, remove such gate or obstruction, and if such gates or gates be located, hung and arranged lave not been gate or obstruction, and if such gate or gates be located, hung and arranged have not been removed within the time as stated in such

be located, hung and arranged have not been removed within the time as stated in such notice, then the same can and shall be re-moved by the proper authorities of the borough of Glenfield at the proper cost and expense to party or parties, companies, cor-porations or associations owning and main-taining such gate or gates. Sec. 2. Any person or persons, company, corporation or association wilfully violat-ing this ordinance, shall, upon conviction be-fore the Burgess or Justice of the Pence of said borough, on first offense pay a fine of three (\$3 00) dollars, together with all costs of suit and collection of fine. Upon con-viction on second and all succeeding offenses the fine shall be not less than five (\$5 00) nor more than \$20, together with all costs of suits and collection of fines. Sec. 3. No person or persons, company, cor-poration or association, or other parties from the date of adoption and passage of this ordi-nance, shall be permitted to crect, place or hing a gate or gates of any description what-soever within the limits of the borough of Glenfield fronting on the street, sidewalk or pavement to swing out or toward the side-walk, pavement or street. Sec. 4. That the Street Committee of said borough Connell are authorized to proceed and enforce the terms of this ordinance.
