



They Refuse to Divulge the Nature of Their Plans-Opinions Regarding the Situation From Producers-Field Reports

The Pittsburg Assembly of the Producers' Protective Association held a largelyattended meeting at 102 Fourth avenue last night. For several days the producers have individually agitated the question whether they should agree to the request of the Southwest Pipe Line Company to the Southwest Pipe Line Company to let the latter concern run the producers' oil into the National Transit Company's lines. 
