RAPID STRIDES TOWARD OUR DEFENSE

WASHINGTON, D. C., Jan. 5.—The annual report of the Inter-State Commerce Commission states that there has been a marked improvement during the past year in the disposition of carriers toward compliance with the law.

Illustrations are given of certain devices which have been adopted by carriers for the purpose of reducing rates without previous publication of the contemplated reductions.




