

PLANS OF BIGELOW Explained to the Park Committee While Out in Carriages.

A SHELTER HOUSE AT HIGHLAND. An Observatory at Schenley and a Driving Track Around It. COMMITTEE SURPRISED AND PLEASED. The visit of the Park Committee to Highland and Schenley parks yesterday was a pleasant and profitable one to the 14 members of the committee who attended.

Up in the ravine there is an old mansion house which is being remodeled to form a shelter for the picnic parties who visit the park daily, and the broad piazzas that are being built around the old dwelling will make it an attractive retreat at all times.

Before leaving the park the Chief took the visitors on a drive to Schenley, a skillfully did to explain the necessity of adding them to the park in order to secure respectable entrance that one or two members of the party who had previously opposed the purchases enthusiastically declared in favor of them.

Superintendent McWhorter ceremoniously welcomed the visitors on arrival at Schenley Park and thereafter became their escort. There were three large Sunday school picnics scattered through the groves and orchards, and on being informed that this was an almost daily occurrence the visitors were astonished to find that Schenley park had become so popular.

The handsome retaining wall being built on the west hill of stone quarried in the park and the system of road building being pursued were examined and favorably commented on. The extent of the stone quarries and the beautiful activity displayed there was examined with interest. All other points of interest and improvement operations were similarly inspected, and while a tany machine was being used to level the ground on the orchard on the most elevated point in the park, future developments were talked of and Chief Bigelow unfolded some of his plans.

One which will probably be executed this year is a half-mile driving track which will be formed on the crest of the south hill from which the Court House, the East End Valley, Oakland and Schenley parks are visible. The valley may all be seen by simply turning the head. With very little expense this beautiful hilltop can be converted into a splendid auto track, and in the center of the valley there is projected the observatory similar to that at Fairmount Park, Philadelphia, from which the view of the surrounding country will be greatly increased.

Why a Driving Park Is Needed. The necessity for a driving park in the park, as explained by Mr. Bigelow, is that there is no place to speed them. It is as if a man or a woman to speed a good horse as it is for a man to eat, and at present, having no other place, the owners use the park drives to test their horses in spite of the vigilance of the police. This is very dangerous to the life and limb of the horse and disagreeable to those who desire to jog along and enjoy themselves quietly.

Before leaving the park the committee was taken to the observatory on the hill. The observatory is a small building on a hill overlooking the city. It is a fine structure and will be a great asset to the park. The committee was very impressed with the plans and the progress of the work.
