Pittsburgh's Appeal From the State to Be Heard in November.

THE CITY OFFICIALS GO EAST.

And Will Arrange for the Argument in the Important Case.

THE MONEY INVOLVED IN THE DISPUTE.

A date for hearing the arguments on the appeal of the city of Pittsburgh against the Commonwealth of Pennsylvania in the matter of State tax imposed on the city's railroad compromise bonds has been set for November 28.

As soon as he received the order from County yesterday, City Attorney Moreland decided to go down to Lancaster and arrange for the arguments with Attorney General Heusel.

Mayor Gourley yesterday sent formal invitations to all the Justices of the State Supreme Court, the Judges of the Circuit and District Courts and all the county judges to review the parade to-morrow from the reviewing stand in Haymarket square, Allegheny, at 1:30 o'clock.
