

Let us humble ourseives before HIM, that in his holy providence we have been involved in a war with a neighboring Republic. In our thanksgivings for the victories he has caused our arms to achieve, let us commend to his compassion the hearts that have been made desolate by the ravages of the sword ; and earnesily pray that a peace, alike honorable to both nations may be restored; and that the whole family of man, united in the bonds of

LANCSATER, O.I., 17, 1746. MELANCHOLY TRAGEDY .- Our city was this

morning the scene of one of the most cold blooded and inhuman murders ever perpetrated in a christain community. It was committed by Join Hagerty, a most desperate character, who was but a few years since convicted of mansaughter, and the persons he deprived of the were Melchoir Fordney, his wife, and child about six years of age. About 9 o'clock.

llagerty was seen to come out of his bouse, next door to Mr. Fordney's, with a double-barrelied gun and axe. At the time his own horse was passing in the street, and setting down his are, he took deliberate aim at the horse, and shot him twice through the body. He then entered Fordney's house, and meeting Mrs. F., inflected upon her head a tremendous blow with the axe, splitting open her skull, and causing instant death. He then attacked and killed Mr. Fordney, and also inflicted several severe wounds upon a little boy, six years of age, from which he has since died. The shooting of the horse in the street caused a crowd to collect, and hearing a cry from inside the house, several entered, when Hagerty was discovered cutting off Mr. Forney's legs with the axe at the thighs.

He immediately attacked those who had entered cape, flourishing his are as he ran, and threatiening to cut down any one who might attempt to arrest him. ' He was pursued, however, and finally knocked down by a stone securely bound, and committed to jail, where he will remain, to await the inevitable punishment tis awful crime will call down upon him.

THE RECENT NEWS FROM MEXICO show an unusal degree of vigor on the part of the government of that country, and the war with that country, from present appearances, is only begun. Salas, which, it is said, have left the Capital, there will be still greater odds for our troops to contend with. Taylor appears, however, to understand his fae, and to be able to engage him at any odds. We expect in a few weeks to hear of another desperate encounter.

DAVID WILMOT, the only member of Congress from Pennsylvania who took-bold and open ground against the Tariff of '42 has been triumpliantly re-elected, over all the com ined forces of federal whiggery. 
