It is truly a tragical affair. Mrs. Sullivan is a small and very delicate female, and we are sure that she must have believed, her honor, and perhaps her life, in great peril, before she could have been induced to take a gun even into her hands. So fearfully alarmed was she, that she fled from the house in her night dress, after firing the gun, leaving her children where they were found, and conveyed to her at the neighbor's house where she had taken refuge.

We learn from a private source that great excitement prevailed the next day, and that public opinion fully justified Mrs. Sullivan.

FROM WASHINGTON.

Correspondence of the Bradford Reporter.
WASHINGTON, D. C. January 7, 1851.

F. O. Goodrich, Dear Sir— I am once more in the city of "magnificent distances," and did not get a line, or let your readers know the subject which agitates the political metropolis. It is now, under the name of the Fillmore Administration, what Daniel Webster as *premier*, is fully committed to the repeal of the Fugitive Slave Law. The policy of Gen. Taylor has been widely and widely, and the next thing is to get the whig party to identify itself with the Administration, and follow its lead.
