RESOLUTIONS. Proposing Amendments to the Constitution of the Commonwealth.

Section 1. The aggregate amount of debts hereinafter mentioned, shall be paid out of the public debt, except in case of war...

Section 2. To pay the public debt of the Commonwealth, and to redeem the public debt, the Legislature shall at its next session...

Section 3. The credit of the Commonwealth shall not in any way be given or loaned to or in aid of any individual, company, corporation or association...

Section 4. The Commonwealth shall never assume the debts of any county, city, borough or township, or of any corporation or association...

Section 5. The Legislature shall never authorize any county, borough or township, by a vote of its citizens or otherwise, to become a stockholder in any joint stock company, association or corporation...

Section 6. The Legislature shall never authorize any county, borough or township, by a vote of its citizens or otherwise, to become a stockholder in any joint stock company, association or corporation...

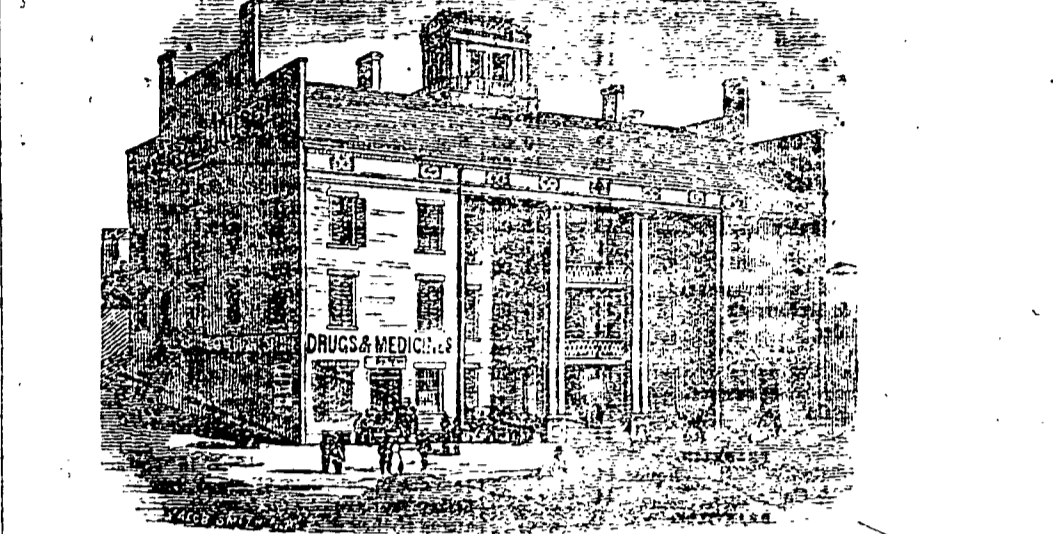

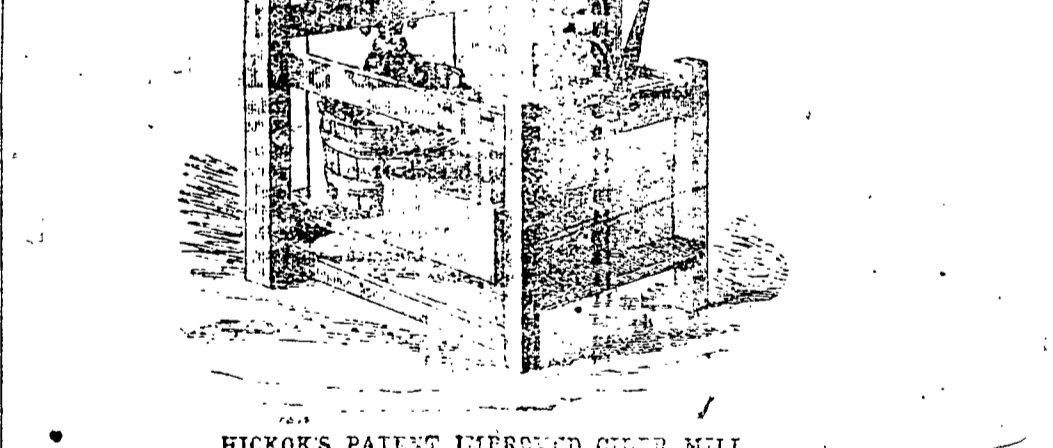
