BUCTION 2. To pay the public debt of the Com-monwealth, and debts which may bereafter be contracted in case of war to repel invasion, suppress insurrection, and to redeem the public dobt, the Legislature shall at th ir next session offer the adoption of this section into the Constitution, provide by law for the creation of a sinking fund, which shall not be abolished until the said public debts be wholly paid, to consist of all the net annual income from the public works and stocks owned by the Commonwealth, or any other funds arising under any revenue law now existing or that may be hereafter enacted, so far as the same may be required to pay the interest of said debts semi-annually, and annually to, reduce the principal thereof by a sum

The credit of the Commonwealth shall not in any way be given or loaned to or in aid of any individual, company, corporation or associa-

tion, nor shall the commonwealth hereafter become a joint owner or stockholder in any company, assoclation or corporation in this commonwealth, or crowthere, formed for any purposes.

SECTION 4. The commonwealth shall never as-sume the debts of any county, city, boro' or towns. thip, or of any corporation or association, unle such debts shall have been contracted to repel invasion, suppress insurrection or to defend the State in war.

PROPOSITION SECOND-TO BE ARTICLE XI. Prohibiting Municipal Subscriptions.

The Legislature shall never authorize any city, county, borough or township, by a vote of its citizene or otherwise, to become a stockholder in any joint stock company, association or corporation, or to raise money for, 'or loan it's credit to, or in aid of eny such company or association.
