ing great loss of human life, has produced intense emotions of sympathy and sorrow throughout the country. It may well be doubted whether these calamitous events are wholly attributed to the necessary and inevitable dangers of the sea. The merchants, mariners and ship builders of the United States, are it is true, unsurpassed in far-reaching enterprise, intelligence and courage, by any in the world. But with the increasing amount of com mercial tonnage in the aggregate, and the larger size improved equipment of the ships now constructed a deficiency in the supply of reliable seamen begins to be very seriously felt. The inconvenience may, perhaps, be met, in part, by due regulation for the introduction, into our merchant ships, of indented apprentices; which, while it would af ford useful and eligible occupation to numerous young men, would have a tendency to raise the character of seamen as a class. And it is deserv-ing of serious reflection, whether it may not be desirable to revise the existing laws for the maintenstrate of discipline at sea, upon which the security of life and property on the ocean must to so great an extent depend. Although much attention has already been given by Congress to the proper con struction and arrangement of steam vessels and all passenger ships, still it is believed that the achievements of science and mechanical skill in this di direction have not been exhausted. No good rea son exists for the marked distinction, which appears upon our statutes between the laws for protecting life and property at sea, and those for pro-tecting them on land. In most of the States severe penalues are provided to punish conductors of trains, engineers, and othars employed in the transtation of persons by railway, or by steamboats on rivers. Why should not the same principle be applied to acts of insubordination, cowardice, or other misconduct on the part of masterrs and mariners, producing injury or death to passengers on the high seas, beyond the jurisdiction of any of the states, and where such delinquences can be reach-ed only by the power of Congress? The whole subject is samestly commended to your consider-

THE POST-OFFICE.

The report of the Post Master General, to which ou are referred for many interesting details in re ion this important and rapidly extending branch of the public service, shows that the expenditure of the year ending Jane 30, 1854, including one undred and thirty-three thousand four hundred and eighty-three dollars of balance due to foreign fices, amounted to eight million seven hundred and ten thousand nine hundred at d seven dollars. to six million nine hundred and fifty-five thousand five hundred and eigh y-six dollars ; exng an expenditure over income of one million even hundred and fifty five thousand three hun d and twenty one dollars, and a diminution of deficiency, as compared with the last year, of three houdred and sixty-one thousand seven hundred &

fiv-six dollars. The increase of the revenue of epartment, for the year ending June 30, 1854, over the preceding year, was nine hundled and seventy thousand three hundred and ninety-nine ollars. No proportionate increase, however, can e anticipated for the current year in consequence the act of Congress of June 23, 1854, providing increased compensation to all post masters om these statements it is apparent that the Postflice Department, instead of defraying its expens, according to the design at the time of its crein, is now, and under existing laws must con-te to be, to no small extent, a charge upon the eral treasury. PUBLIC LANDS.

During the last fiscal year eleven million sevenousand nine hundred and thirty five acres of public lands have been surveyed, 8,190,017 es brought into market. The number of acres is 7,035,735, and the amount receiverefor \$9,285 533. The aggregate amount of sold, localed under military scrip and land ants, selected as swamp lands by States, and

marine disasters of the most tragic nature, involv. schemes and extravagance. But it is manifest that, with the most effective guards, there is danger of

with the most enceuve guards, there is danger of going too fast and too far. We may pause before a proposition contemplat-ing a simultaneous movement for the construction of railroads, which in extent will equal, exclusive of the great Pacific road and all its branches, nearly one-third of the entire length of such words, now completed, in the United States, and which cannot cost, with equipments, less than one hundred and fity-millions of dollars. The dangers likely to re-sult from combinations of interests of this character, can hardly be over estimated. But, independently of these consideratious, where is the accurate knowledge, the comprehensive intelligence, which shall discriminate between the elative claims of these twenty-eight proposed roads, in eleven States and one Territory ? Where will you begin, and where end ? If to enable these companies to execute their proposed works, it is necessary that the aid of the General Government be primari y given, the policy will present a problem so comprehensive in its bearings, and so important to our political and social well being, as to claim, in anticipation, the severest analysis. Entertaing these views, I recur with satisfaction to the experience and action of the last session of Congress, as furnishing assurance that the subject will not fail to elict a careful reexami-

nation and rigid scrutiny. INTERNAL IMPROVEMENTS.

It was my intention to present, on this occasion, some suggestions regarding internal improvements by the General Government, which want of time at the close of the last session prevented my submitting on the return to the House of Representatives with objections of the bill entitled " An act making appropriations for the repair, preservation and completion of certain public works heretofore com-menced under authority of law ;" but the space in this communication already occupied with other matter of immediate public exigency constrains me JUDICIARY.

The judicial establishment of the Unitel States requires modification, and certain reforms in the manner of conducting the legal business of the gov vernment are also much needed; but as I have addressed you upon both of these subjects at length before, I have only to call your attention to the suggestions then made.

DISTRICT OF COLUMBIA.

My former recommendations, in relation to suitable provision for various objects of deep interest to the inhabitants of the District of Columbia are renewed. Many of these objects partake largely of a national character, and are important, indepen-dently of their relation to the prosperity of the only considerable organized community in the Union entirely unrepresented in Congress.

I have thus presented suggestions on such sub-jects as appear to me to be of particular interest or importance, and therefore most worthy of consideration during the short remaining period alloted to the labors of the present Congress. PERORATION. Our forefathers of the thirteen United Colonies, in






